PLEASE TAKE NOTICE, the following conduct occurred on the premises commonly known as Weedz Alternatives, 628 S. Las Vegas Blvd., Las Vegas, NV 89101.

The property at 628 S. Las Vegas Blvd., Las Vegas, NV 89101, continues to have violent calls for service/problems requiring police response. This is believed to have been in part to inaction on the part of the management and ownership in taking care of problems on their property. The following is a breakdown of significant calls for service and specific problems on the property within the 30 day period of 7/03/10 to 08/03/10.

Event# 100224-2014: Officers were dispatched to the corner of Las Vegas and Garces reference to male subjects who appeared injured lying down on the sidewalk. The two individuals identified themselves as Matthew Carr and Christopher Donoughe. Donoughe vomited in front of officers, could not remember his social security number and misspelled his name when asked for it. Carr stated that they had purchased a substance at a nearby smoke shop and smoked it there on the premises. Officers went to Weedz Alternatives less than a block away and spoke to the owner Steven Vogt. Vogt stated that Carr and Donoughe had purchased "King Krypto" from his store for \$20. Both Carr and Donoughe were transported to Valley Hospital by LVFD Rescue 4.

Event# 100803-1806: On 8/3/10 a customer inside of business called/notified the police after business owner Steve Vogt began yelling and screaming at all the customers inside and reportedly began throwing ashtrays at them. All involved parties were gone upon police arrival.

Event# 100803-4228: On 8/3/10, Officers responded to a loud noise complaint to the business known as the Weedz Alternatives. Once arrived, store owner Steven Vogt and others inside refused to open the door to officers in order to investigate the complaint. Officers noticed Vogt's forearm was cut/bleeding and refused to answer any questions. Officers arrested Vogt for Obstructing a Police Officer and booked into city jail.

Business Licensing Violations - 8/12/10: Business License Officer Latania Webb attempted to conduct an inspection of the business along with Officers Thompson and Officer Klingner. During

BUSINESS LICENSE DATA:

Weedz Alternatives, 628 South Las Vegas Boulevard (S15-00082-3-140062), under the ownership of Steven Vogt, sole proprietor 100% is currently licensed to operate within the City of Las Vegas as a retail smoke shop selling herbs and smoking accessories. The location was issued a permanent City of Las Vegas Business License December 02, 2009.

CHRONOLOGY OF EVENTS:

Tuesday, October 14, 2008 1417 hours

Received copy of application and directed to conduct an inspection to verify business activity.

Tuesday, October 14, 2008 1454 hours

I arrived on-site at business and identified myself to Steven Vogt, owner and informed him that I needed to conduct an interior inspection of his business, which is the final step in him obtaining his business license. I observed several types of glass pipes (water pipes, bongs, glass vials & chillers). I also observed legal smoking herbs and pills (salvia, kratom, legal bud). **Mr. Vogt stated that he has no intention of selling hookahs or having a hookah lounge or any onsite activity other than people purchasing his items and leaving the premise. I advised him that if he does decide to change the scope of his business activity that additional licenses will be required.** Currently the front area is made up of sales display cases and bookshelves with pipes and herbs. There is a temporary wall located west behind the display counter that leads to the storage area, restroom & back entrance. Mr. Vogt stated the wall is temporary because he is anticipating expanding the sales area once his business picks up. I advised him that he should post signs inside the store stating that the items are for legal smoking use only. There was one box of choyboys that I had him remove from the sales area.

Wednesday, October 15, 2008

I emailed Senior License Officer Minerva Gomez of findings and to allow issuance of the license.

Monday, October 27, 2008

Steven Vogt, owner in office to amend his application to state "No tobacco sale". Application re-classed from gifts & novelties to Smoke shop classification.

Tuesday, October 28, 2008 0846 hours

After getting City Attorney opinion on glass vials, I re-opened case to conduct a follow-up inspection to have glass vials removed.

Tuesday, October 28, 2008 1217 hours

License Officer II Kelly Oliverius & I conducted a re-inspection of the business. Mr. Vogt, owner was on-site. I informed him that the small glass vials/tubes and clear glass vials with the bulbs on the ends need to be removed per City Attorney opinion. Mr. Vogt retrieved all the glass pipes in question and destroyed them immediately by crushing them and putting the pieces out in the trash. He stated he understands he will not be able to carry that product. He also confirmed that he will not be selling any nicotine tobacco products, only herbs.

Wednesday, November 6, 2008

Temporary license issued; effective November 5, 2008 expires April 30, 2009.

Thursday, November 20, 2008

I conducted a routine inspection. Steven Vogt, owner on-site during inspection. Verified hours will be Monday-Thursday 12:00pm to 10:00pm; Friday-Sat 12:00pm-12:00am; Sunday 12:00pm-6:00pm. I observed no tobacco products, no drug paraphernalia and no adult items; just the various glass pipes and herbs. Mr. Vogt confirmed there will be no entertainment, no lounge, no membership fees and no lockers. License already classified correctly as a Smoke shop no other license required.

Wednesday, January 14, 2009

I received directive from Jim DiFiore, Manager to conduct two field inspections of the business activity prior to the temporary license expiring April 30, 2009.

Thursday, February 19, 2009

I conducted a routine inspection of the business. Steven Vogt, owner on-site at time of inspection. I observed no customers inside business. I verified the hours of operation had not changed. I did observe that he has added some additional inventory in store; still focusing on smoking herbs and glass pipes. He did have some baggies that he said he uses for some of the piercings he sells and samples of the herbs that he gives away. I had him remove the baggies from display area and put in the back. No drug paraphernalia found.

Monday, April 20, 2009

I conducted a routine inspection of the business. Steven Vogt, owner on-site at time of inspection. I observed that he has added additional inventory such as: gas masks, more water pipes & herbal product. No drug paraphernalia found.

Wednesday, December 2, 2009

Permanent license issued to business.

Thursday, August 5, 2010

Victoria Rosemore, Enforcement Supervisor received an email from DTAC Officer Zachary Johnson regarding problems and concerns with the business, Weedz Alternatives. Officer Johnson has concerns regarding the knives and some of the herbs that are being sold there. Their office is attempting to do a chronic nuisance and needs all the evidence they can to pursue. A directive was forwarded to me to contact Officer Johnson and conduct a routine inspection. I contacted Officer Johnson and informed him that I was going to do an inspection on August 12, 2010. He asked if he could accompany me to the inspection. We scheduled a time to meet there at 1230 hours.

Thursday, August 12, 2010

At approximately 1230 hours License Officer Jim Azar & I met LVMPD DTAC COP officers Zachary Johnson and his partner onsite to conduct a routine inspection. Steven Vogt, owner, two employees and approximately four customers were on-site at time of inspection. I asked Mr. Vogt, if he remembers me and he said yes I am the City inspector that comes in at times to check his store. I advised that I was there to do another routine inspection and that I was training the other people who were with me. Mr. Vogt was apparently under the influence of something. His behavior was erratic, talking to himself at times, dancing around and being obnoxious. I tried to conduct my inspection and ask him some questions regarding the items that I observed that had been added to this store, but he could not focus and kept wondering off. I observed he has added knives, swords, posters, sunglass cases, auto accessories, adult DVDs & swisher mini & large cigars. I tried to explain to him that he is operating outside the scope of his license and will need to obtain additional licenses (tobacco & gifts & novelties) but he kept talking to himself and I clearly could see he didn't understand what I was saying. During the inspection, several customers came into the business looking like they were high off something and some smelling of marijuana. I tried to inspect the rear room which is now hidden by a black curtain, but Mr. Vogt became irate, pushing me out of the way and blocking the entrance while screaming that I have no right to inspect that area. I tried to make him understand that by Code, I can inspect the entire premise, but there was no getting through to him in the condition he was in, so due to his threatening nature, I backed away and ended my inspection. I asked one of his employees, Dewey Belvin how long has he been in this condition and he stated, "for about 2-3 weeks. He mixed some of the herbs together and has been this way every since". I informed Dewey that Mr. Vogt will require additional licensing and I need to have him come into our office for a meeting, possibly next Thursday. I told him I will call him once I have scheduled the meeting time. A short while later, a lady came into the business and Mr. Vogt & she went in the back room behind the black curtain. Mr. Vogt came out but the lady never exited back through the front of the store. Mr. Vogt then came over to me and said he will allow me to go ahead and check the back room. I told him that would be ok! I will continue this at a later date. We all

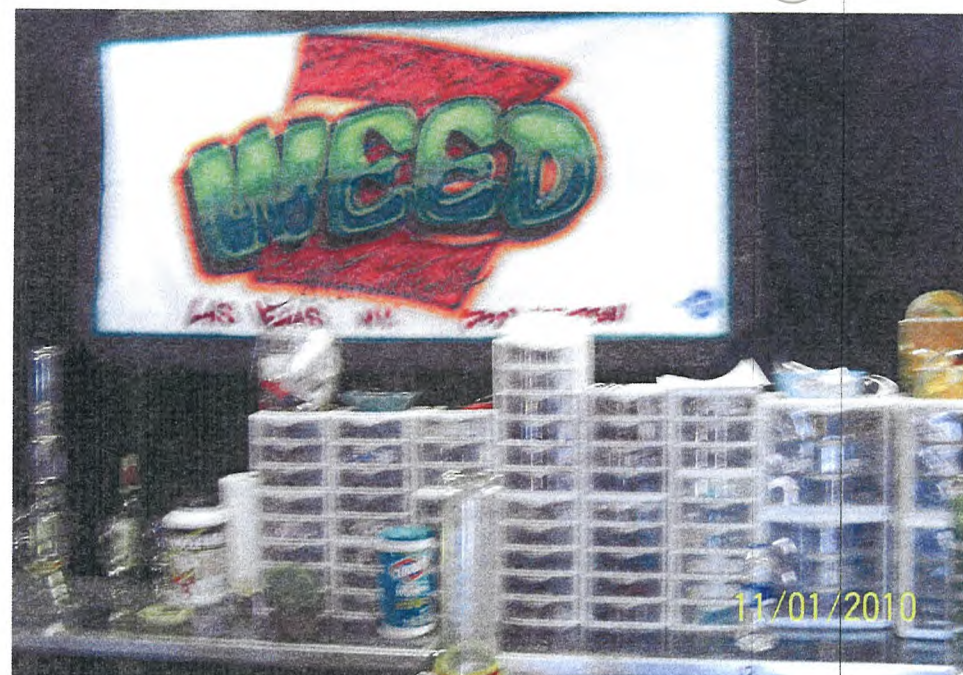
exited the business. A few minutes later Officer Aguirre & Officer Perry arrived on-site to serve Mr. Vogt with a chronic nuisance letter. We went back inside the business and videotaped Mr. Vogts' actions.

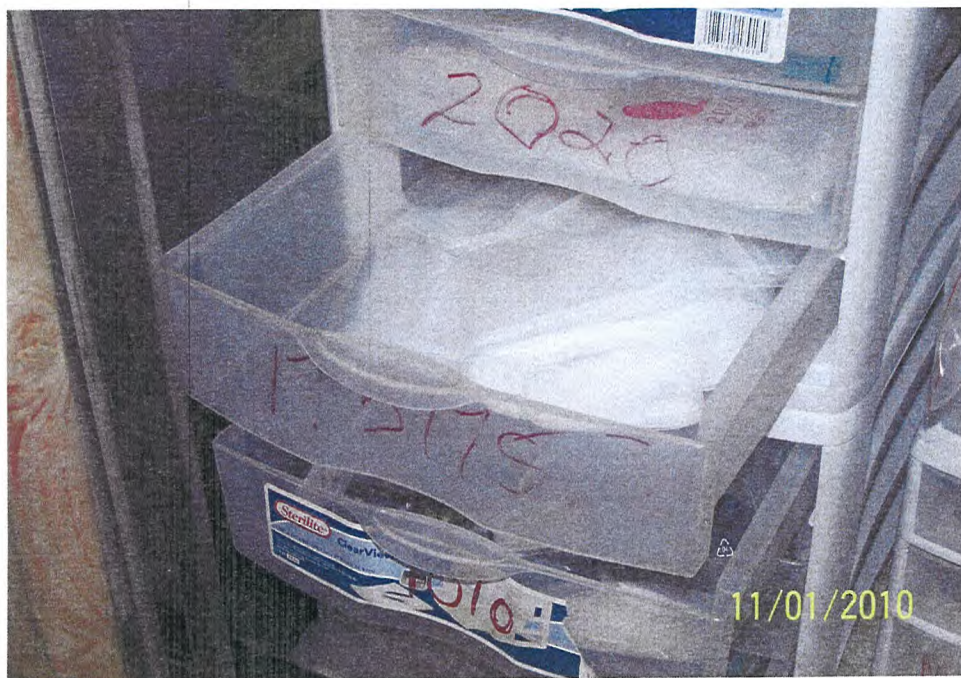
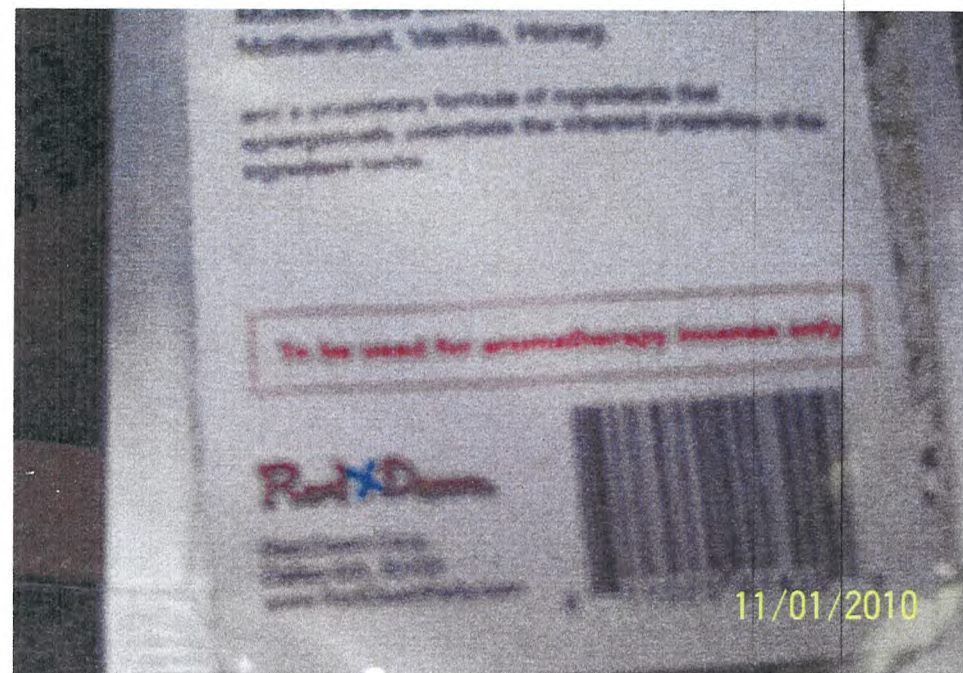

On 2-24-10 at approximately 1309 hours, I Officer R. Thompson [REDACTED] responded to Las Vegas Boulevard and Garces reference a call of a male down on the sidewalk. Upon arrival Las Vegas City Fire Rescue #4 was on scene and they were with two subjects. Both subjects (Matthew Carr [REDACTED] and Christopher Donoughe [REDACTED]) appeared to be under the influence of some type of substance. Donoughe vomited in my presence and appeared to have a blank stare while Carr made statements that led me to believe he had hallucinated and he had no track of time. Officer B. Gastelum [REDACTED] also arrived and spoke with Donoughe and stated to me that he could not recite his social security number and also misspelled his name when he asked him. Carr stated that they had smoked a substance inside of a nearby store. I walked around the corner and entered the Z Weed Alternatives store located at 628 S. Las Vegas Boulevard and spoke with a subject named Steven Vogt, [REDACTED] who would later state he was the owner of the store. I advised him that some subjects stated they had smoked something from his store. I asked what they had taken and he handed me a metallic, vacuum sealed pouch that stated "King Krypto" on the front with a picture of a lion and had writing on the reverse. I asked if I could show the subjects what the item was so I could confirm this was indeed the item and I advised him I would bring it back and Vogt stated yes. Upon showing it to Carr he stated this was the item. Carr would later state that they paid twenty dollars for the substance and that he took a one and a half "hits" off of a water pipe inside of store. Donoughe would tell me that he took two "hits". Carr stated that he tossed the item when I asked what he did with the rest of it. Due to all the above circumstances I contacted LVMPD narcotics detective B. Grammas [REDACTED] and advised him of the call. Las Vegas City Fire Rescue 4 transported both Carr and Donoughe to Valley Hospital and shortly thereafter, Grammas and Sgt. P. McCullough [REDACTED] arrived at my location. While speaking with Grammas, he observed a pouch on the ground near our location and it appeared to be the same item due to it stating "King Krypto" and having the same picture on the front. Detective Grammas, Sgt. McCullough, Officer Gastelum and myself then entered the store and Grammas spoke with Vogt. Detective Grammas advised me to complete and Officers Report and to forward a copy to him. Sergeant C. Rodriguez [REDACTED] was advised also.

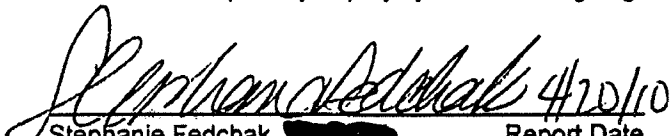

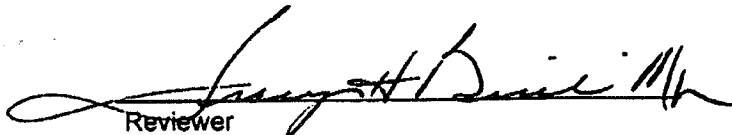

On 9-29-10 around 1555 I Officer D. Arciniega [REDACTED] while operating as marked patrol unit 3C33 and Officer N. Doble [REDACTED] while operating as marked patrol unit 3C55 respectively responded to a call in the area of 600 S. Las Vegas Blvd LV, NV 89101. Upon arrival we made contact with a subject who was laying face down on the sidewalk with his head close to one of the businesses in the area and his feet closer to the roadway, with an unknown pink liquid on his face. The subjects eyes were open, but he seemed dazed and confused and was unresponsive to questioning.

The only thing the subject said when he was questioned was "I'm going to die." Upon closer observance it appeared the pink liquid on his face was vomit, and there was more pink vomit on the sidewalk in several places in the general vicinity where the subject lay.

AMR 2725 responded to the location and put the subject on the stretcher. The subject was then identified as Cedric Brown, [REDACTED], using his Nevada Drivers License. While Brown was being loaded into the ambulance he would have brief periods of time where he was coherent and able to respond to questioning. During these periods Brown was questioned and at first he was worried asking if he was in trouble and if he was going to jail. After being told he wasn't in trouble brown said he walked into the WeedZ Alternatives shop, located at 628 S Las Vegas Blvd LV, and he said they gave him a "free sample" of "Hydro." Upon being questioned if he had any King Crypto, Brown said that was what he smoked. Brown also became erratic and started screaming different things saying he smoked from a big bong and that it was "good stuff." Brown also started screaming "who am I" sounding like a rooster. When told to calm down Brown would scream at officers and medical personnel asking if they told their moms to calm down today. Brown continued screaming random things until he was sedated by Alfonso Ramirez, one of the responding AMR medical personnel. Brown was transported by ambulance to Valley hospital.

Officers contacted WeedZ Alternatives and spoke with the store manager a Theresa Chapin, [REDACTED], who said she remembered the subject and said he walked into the store and started smoking from one of the bongs without asking for permission from the employees. When asked if officers could see the bong that was used another employee started taking out different bongs that were behind one of the counters, not within easy reach, putting several bongs on the counter. Pictures were taken of the bong that was believed to be used after receiving permission from Chapin. Residue was also observed on the bong believed to be used.

On 2-24-10 at approximately 1309 hours, I Officer R. Thompson [REDACTED] responded to Las Vegas Boulevard and Garces reference a call of a male down on the sidewalk. Upon arrival Las Vegas City Fire Rescue #4 was on scene and they were with two subjects. Both subjects (Matthew Carr [REDACTED] and Christopher Donoughe [REDACTED]) appeared to be under the influence of some type of substance. Donoughe vomited in my presence and appeared to have a blank stare while Carr made statements that led me to believe he had hallucinated and he had no track of time. Officer B. Gastelum [REDACTED] also arrived and spoke with Donoughe and stated to me that he could not recite his social security number and also misspelled his name when he asked him. Carr stated that they had smoked a substance inside of a nearby store. I walked around the corner and entered the Z Weed Alternatives store located at 628 S. Las Vegas Boulevard and spoke with a subject named Steven Vogt, [REDACTED] who would later state he was the owner of the store. I advised him that some subjects stated they had smoked something from his store. I asked what they had taken and he handed me a metallic, vacuum sealed pouch that stated "King Krypto" on the front with a picture of a lion and had writing on the reverse. I asked if I could show the subjects what the item was so I could confirm this was indeed the item and I advised him I would bring it back and Vogt stated yes. Upon showing it to Carr he stated this was the item. Carr would later state that they paid twenty dollars for the substance and that he took a one and a half "hits" off of a water pipe inside of store. Donoughe would tell me that he took two "hits". Carr stated that he tossed the item when I asked what he did with the rest of it. Due to all the above circumstances I contacted LVMPD narcotics detective B. Grammas [REDACTED] and advised him of the call. Las Vegas City Fire Rescue 4 transported both Carr and Donoughe to Valley Hospital and shortly thereafter, Grammas and Sgt. P. McCullough [REDACTED] arrived at my location. While speaking with Grammas, he observed a pouch on the ground near our location and it appeared to be the same item due to it stating "King Krypto" and having the same picture on the front. Detective Grammas, Sgt. McCullough, Officer Gastelum and myself then entered the store and Grammas spoke with Vogt. Detective Grammas advised me to complete and Officers Report and to forward a copy to him. Sergeant C. Rodriguez [REDACTED] was advised also.

I then called 311 and I informed them of the situation. During the call we were temporarily disconnected and during the disconnection is when the WM beating on the glass door with his fists and then pulling on it attempting to get in.
