4. The sign must meet the display requirements of the City of Las Vegas' Street Naming and Address Assignment Regulations, 2009 edition.
5. All signage, including temporary signage, shall have proper permits obtained through the Building and Safety Department.
6. All signs must be fully illuminated at night from dusk until dawn.
7. All City Code requirements and design standards of all City departments must be satisfied.

**** STAFF REPORT ****

PROJECT DESCRIPTION

This is a signage review request for the Las Vegas Library and Lied Discovery Children's Museum at 833 Las Vegas Boulevard North. The property is located within the Las Vegas Boulevard Scenic Byway Overlay District. The applicant is proposing a 32 square-foot, double sided freestanding sign with blue and red exposed neon bordering the top portion. "Las Vegas Library" will be spelled out in red exposed neon and "Lied Discovery Children's Museum" spelled out in blue exposed neon.

Staff is recommending approval of this request, as the proposed signage meets the requirements of the Las Vegas Boulevard Scenic Byway Overlay District. If this request is denied, the proposed signage will not be permitted. The applicant may appeal the board's decision or present a redesigned sign at a future date. If approved, a permit cannot be issued for 14 days, after which the appeal period will have expired.

ANALYSIS

This is a signage review request for the Las Vegas Library and Lied Discovery Children's Museum at 833 Las Vegas Boulevard North. The property is located within the Las Vegas Boulevard Scenic Byway Overlay District. The applicant is proposing a 12 foot tall, 32 square foot, doubled sided freestanding sign. The sign will have blue and red exposed neon bordering the top portion. "Las Vegas Library" will be spelled out in red exposed neon and "Lied Discovery Children's Museum" spelled out in blue exposed neon.

The proposed signage meets the illumination requirements of the Las Vegas Boulevard Scenic Byway District. The signage concept meets the design intent of the Las Vegas Boulevard Scenic Byway District, which seeks to preserve the tradition of neon art and encourage signage that will enhance the district as a nationally recognized place. Therefore, staff supports the proposed signage and recommends approval.
