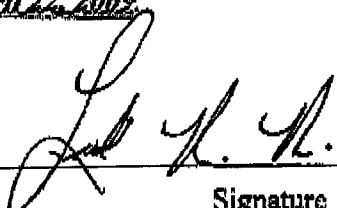

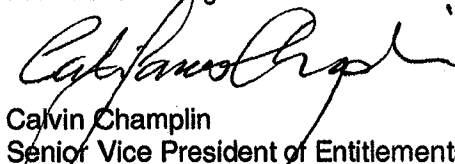
Dear Dave:
