We don't need another drive-thru eatery in this area! Sea Breeze Village is already congested w/ traffic. No variance to required 15 feet of Buffer Zone.

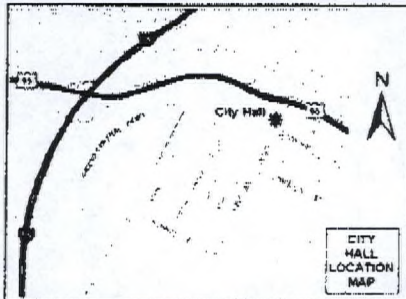
Also, wish to express concern for traffic cutting thru the Sorrento sub division to Access along Pacific Terrace to Sea Spray.
