CHAIR TROWBRIDGE declared the Public Hearing open.

PLANNING COMMISSION MEETING OF: MAY 28, 2009

PETER LOWENSTEIN, Planning and Development, stated the site consists of a hotel and retail shops with an existing sign located along Las Vegas Boulevard that is in poor condition. The applicant proposes to locate a wireless communication facility of stealth design within the existing sign. The antennas will be contained in the pole section of the existing sign with the associated equipment located on the roof of the building towards the rear of the property, where it will not be readily visible from the public right-of-way. The star embellishment at the top of the existing sign will be replaced with a new embellishment of the same design with neon light to meet the requirements of the Las Vegas Boulevard Scenic Byways Overlay District. Staff recommended approval, as the proposed facility will have minimal impact on the adjacent properties and will be compatible with the surrounding land uses. MR. LOWENSTEIN recommended an amendment to Condition 1 to reflect Title 19.04.01.

JASON FRAYER, 323 Greenleaf Glen, appeared on behalf of the applicant and agreed with condition.

TODD FARLOW, 240 North 19th Street, verified that the pole will be reconditioned.

COMMISSIONER GAYNES pointed out that the proposed facility is appropriate and should be a benchmark for future requests.

CHAIR TROWBRIDGE declared the Public Hearing closed.
