We understand that all LV Planning Commission actions may set a precedent for any and all actions within our City of Las Vegas, NV boundaries, therefore imposing a direct impact upon all wards.

#18. & 19. We noted that this item is TEMPORARY. While such a facility is an asset to a neighborhood, a shopping center may not be most healthy or safe for the children.

#24. YES, such a service is important to our city.

#31. NO, sounds as though the 'downtown development area' standards are now being requested elsewhere!

Absolutely NO ZERO ft. distance separation from a similar use.

Adhere precisely to NO LESS than a 1,500 ft separation from a city (any) park.

#32. NO, wherever they relocate possibly chauffer service would be the answer?

#33. YES, we are concerned about possible harassing which is used by our council for certain applicants. The reception various applications receive from commissioners sometimes brings out your dramatic side (*added here because similar and smaller applicants seem to receive less than welcome attitudes*).

#34. Yes, and thank you for compliance with some of the latest findings regarding current wind systems for energy production. We may have missed any reference to turning off the blades when not needed, but that is a factor we had recently read.
