JUSTIFICATION LETTER

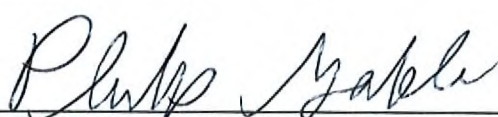
