CHAIR TROWBRIDGE declared the Public Hearing open.

DOUG RANKIN, Planning and Development, explained that the proposed addition is internal to the site and the use is harmonious with the college. Staff recommended approval, as it meets the conditions of approval.

RAY FINKEL, SH Architecture, 7373 Peak Drive added that the proposed two-story addition will add 18,000 square feet to an existing 85,000 square-foot, four-story building, and the architecture will be compatible with the existing structure.

SHERRI PAYNE, College of Southern Nevada, indicated a generous donation was received from the Englestad family, which will assist in the Health Science Department, specifically the Cardiorespiratory Program.

BART ANDERSON, Public Works, read an amendment to Condition 1.

COMMISSIONER QUINN expressed her excitement and support for the project.
