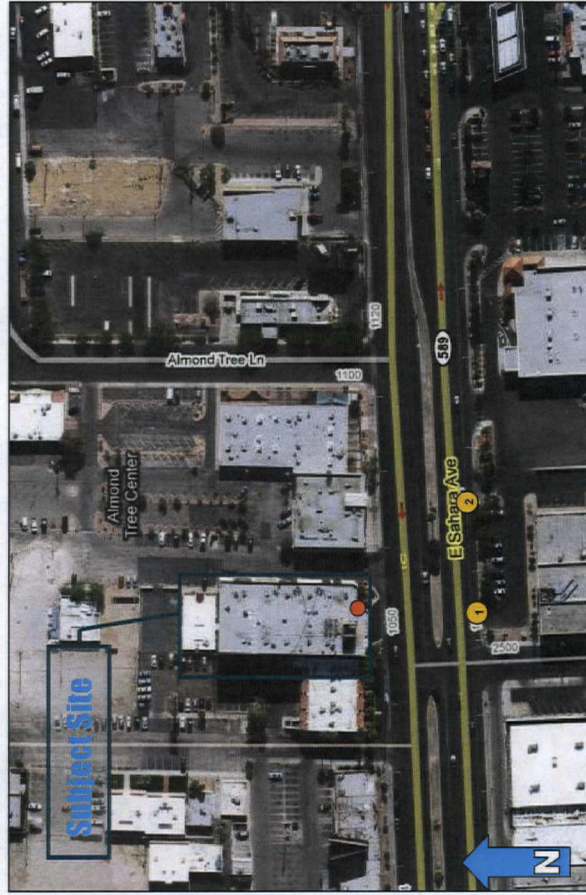

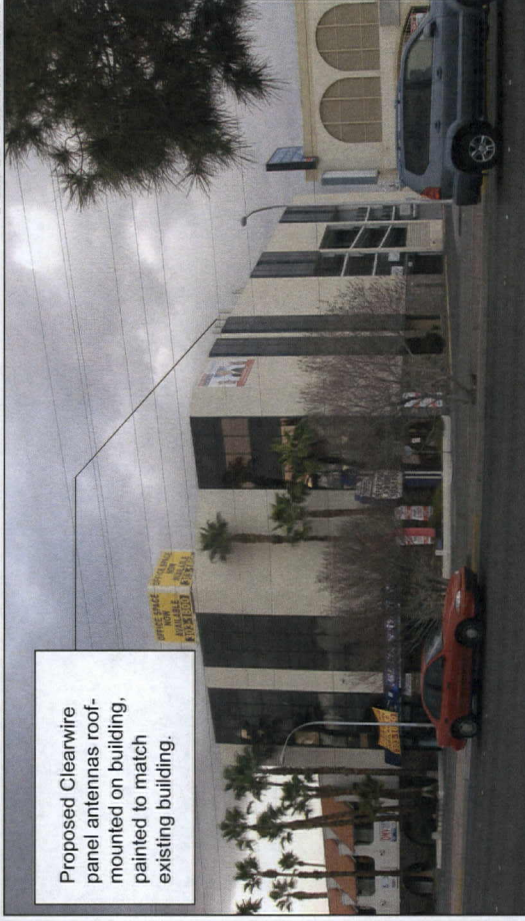

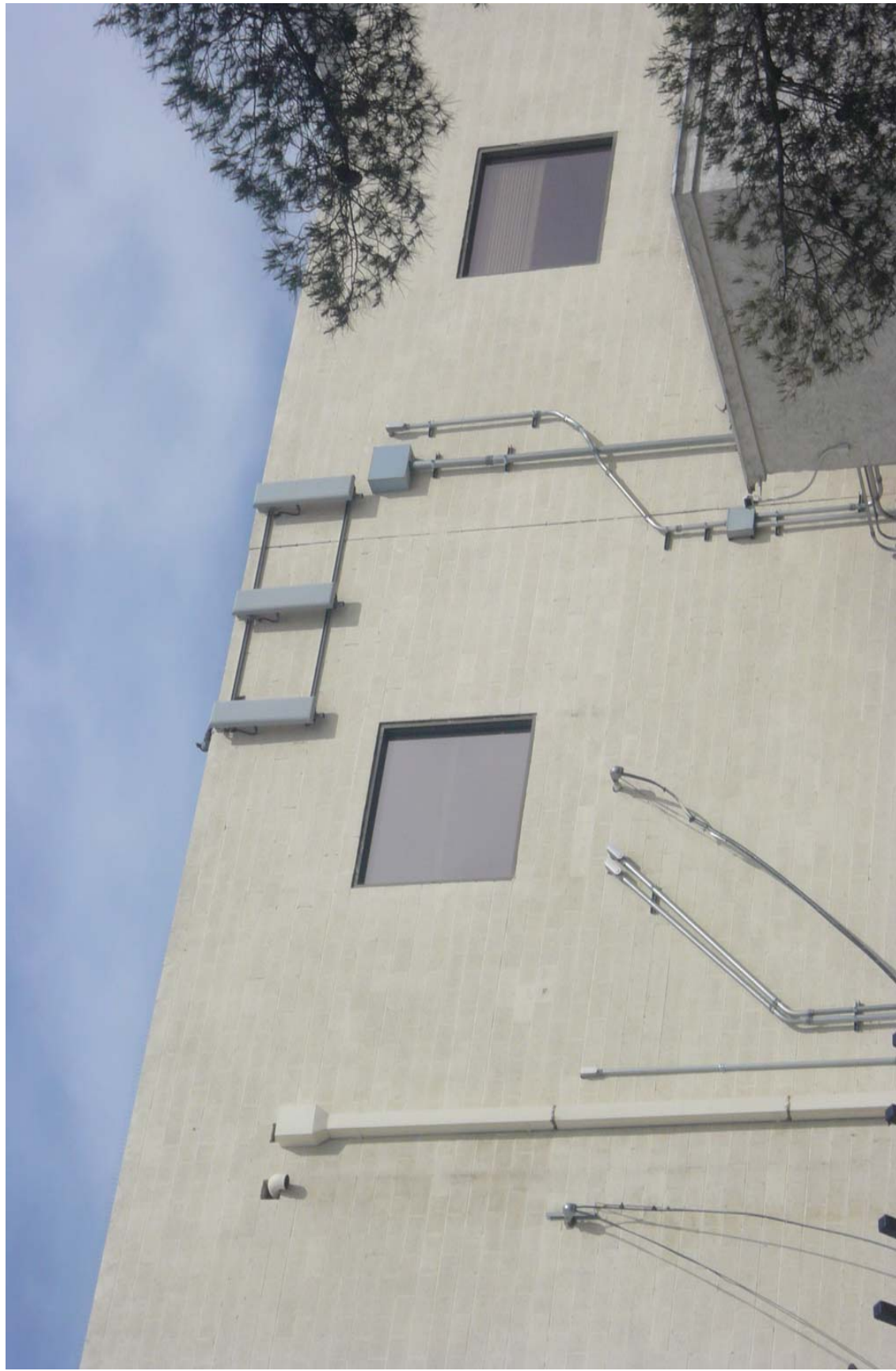


Proposed Clearwire panel antennas roof-mounted on building, painted to match existing building.



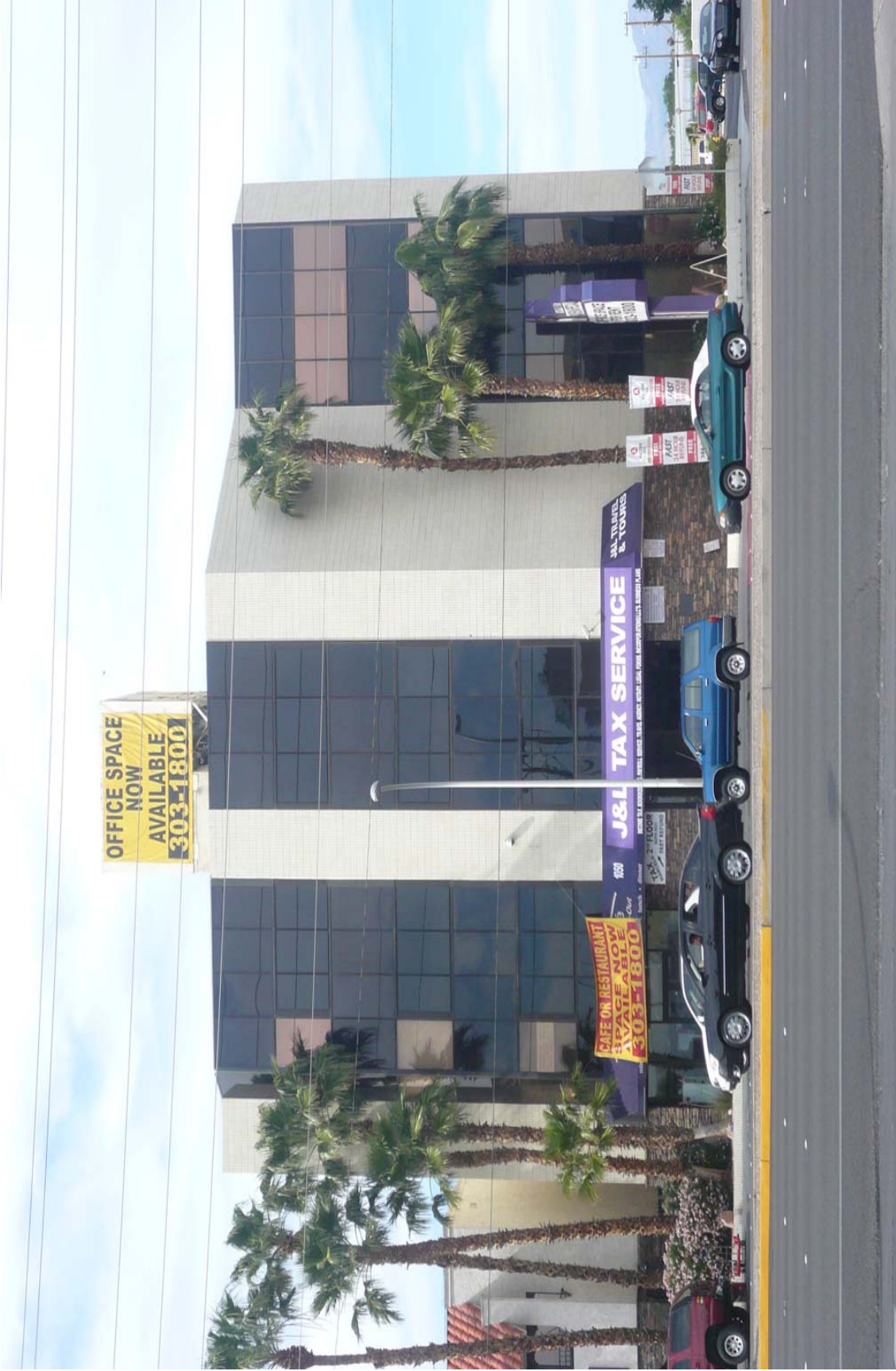
