Comments: This Rezoning Project (1) violates the Las Vegas Medical District Plan, amended 8/1/07, by going outside its bounds, without necessary public hearings by the Planning Commission and City Council; (2) It also violates Goal 2 of Neighborhood Revitalization of the Las Vegas Master Plan 2020; (3) It will cause even a **more dangerous degree of congestion on Charleston Blvd than now exists in front of UMC**, with both a high volume of cars entering and exiting Charleston to and from the proposed parking lot and all the people from those cars crossing Charleston to go to and from UMC. UMC already has a surface parking lot on the northwest corner of Charleston and Shadow – Use it optimally by building a parking garage. **This Rezoning Project is ill conceived, with almost no serious consideration or planning for its negative impact on the surrounding community and should not be approved. The negative impact on already-heavily congested eastbound Charleston Blvd will be a disaster.**

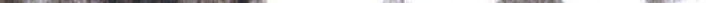
