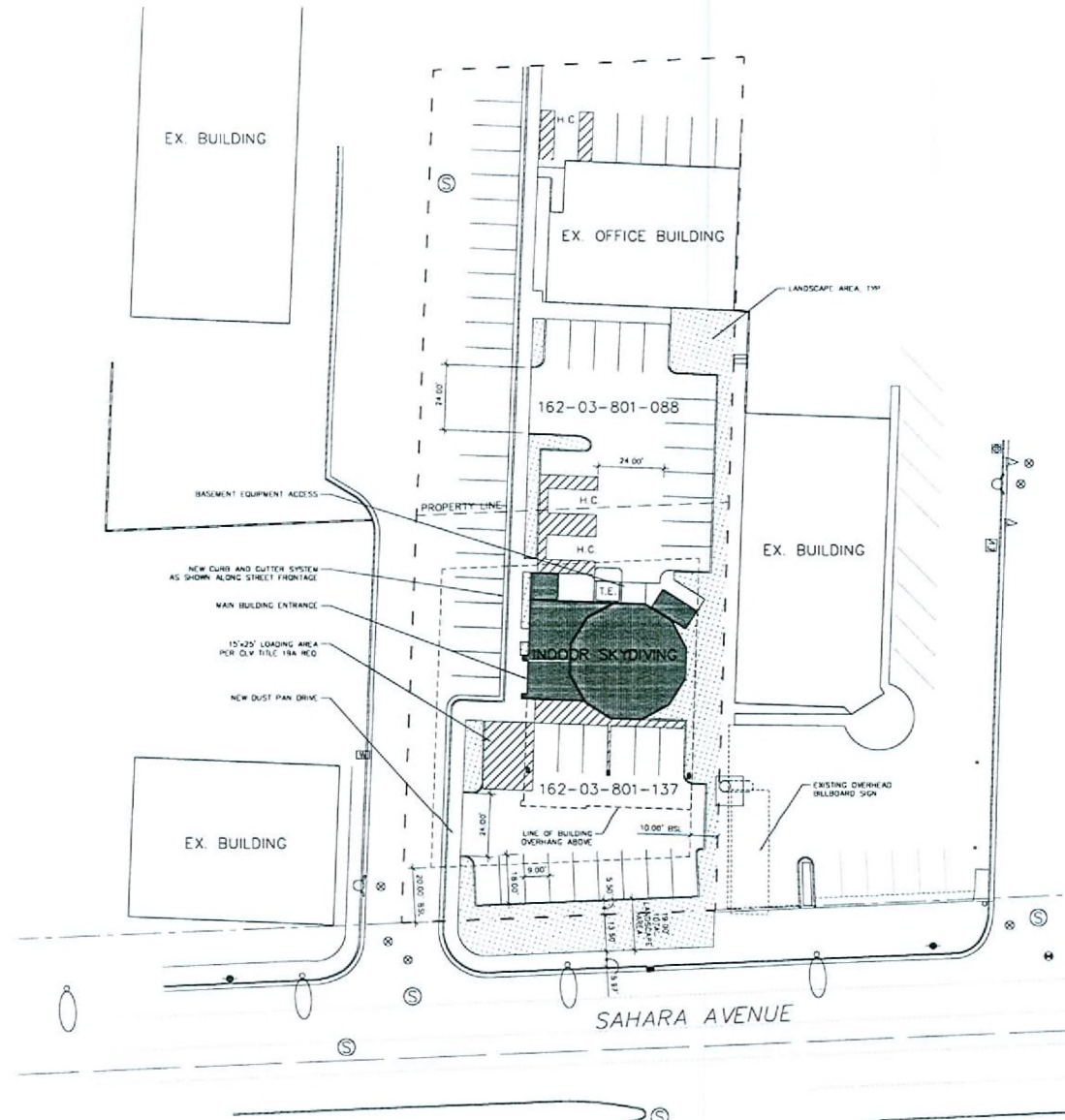

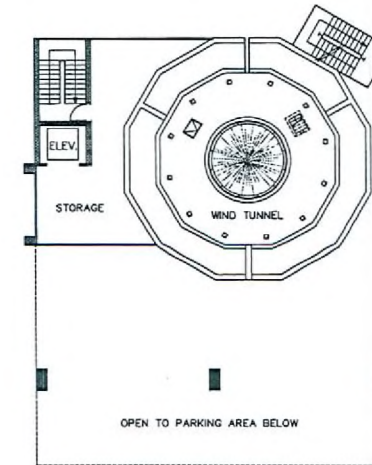
Level B (Basement)



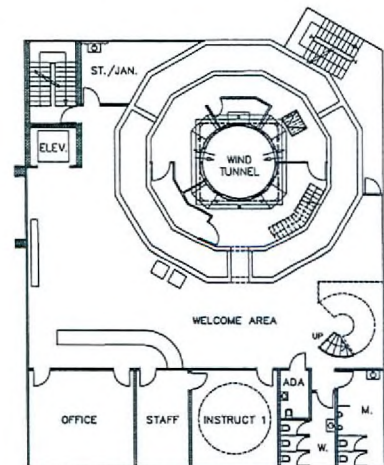
Level 4 (Spectator)
