Dear Mr. Carter:

I am writing this letter as confirmation of the events and timing pertaining to the removal and relocation of the Clear Channel outdoor advertising sign, formerly located on the Fremont West Shopping Center property.

The Nevada Department of Transportation received occupancy of the above-mentioned property through a court order, allowing the Department to begin construction, of the US Highway 95 widening project, on the property. On April 8, 2004, Clear Channel was sent a 30-day notice, from the Department, requiring their sign to be removed from the property within that time. Subsequently, on May 5, 2004, to assist in the construction of the project and in good faith, Clear Channel removed the sign.

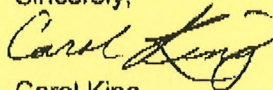
As a part of the relocation process, it is the intention of the Department to allow Clear Channel to relocate the sign to a portion of the remainder of the same parcel, as soon as the State obtains ownership of the property and providing that a mutually agreeable lease is executed. Although the State has been granted occupancy of the property, the ownership will not be granted until either a settlement is made with the owner or the Eminent Domain court case is final. The Department cannot enter into a lease of the property until ownership of the property has been granted to the State. Unfortunately, as this issue is in the hands of the court, a definite timetable for executing the lease and the relocation of the sign cannot be established.

The Department would appreciate all due consideration be given to Clear Channel regarding the issuance of required permits and permit extensions regarding the relocation of this sign.
