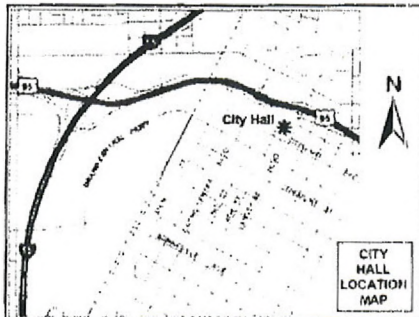
<i>Neighborhood Meeting</i>

The representative from the Nevada Department of Transportation indicated that it supported the project, and that the delay in replacing the sign was due to legal issues beyond the control of the applicant.

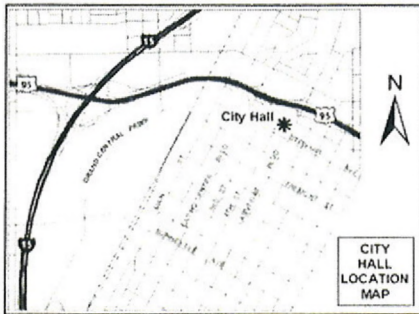
