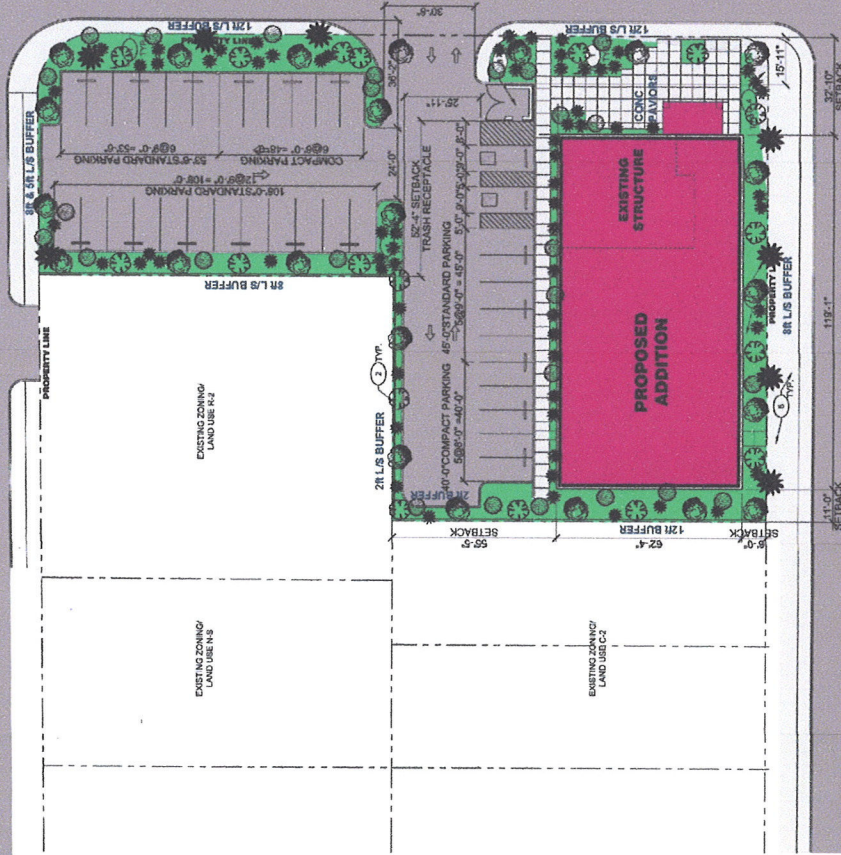

OVERALL SITE PLAN

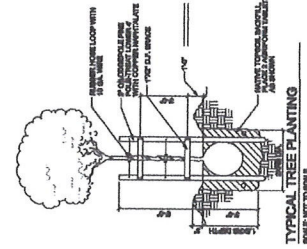

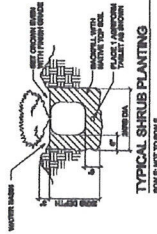
EXISTING ZONING/

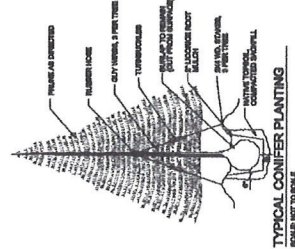

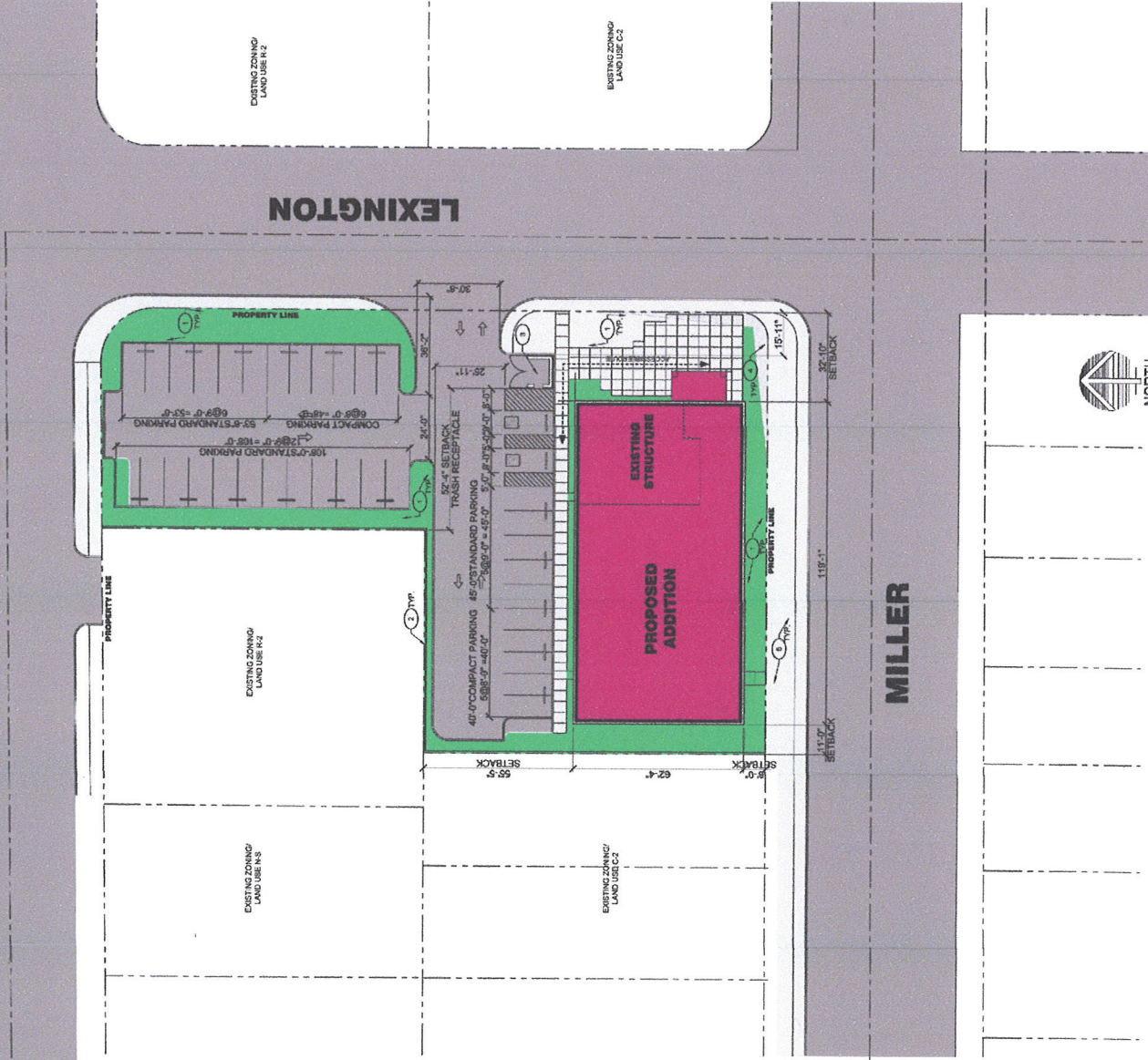

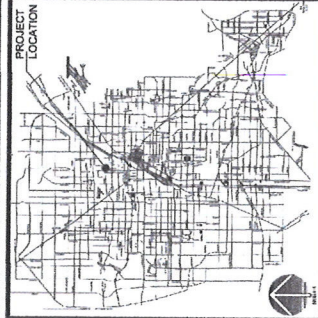

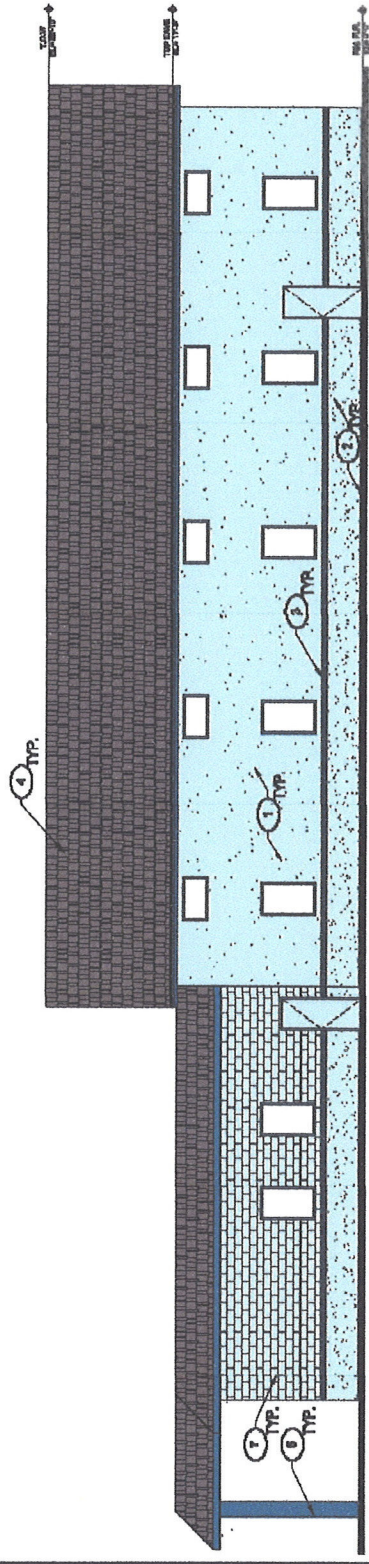
SOUTH EXTERIOR ELEVATION
