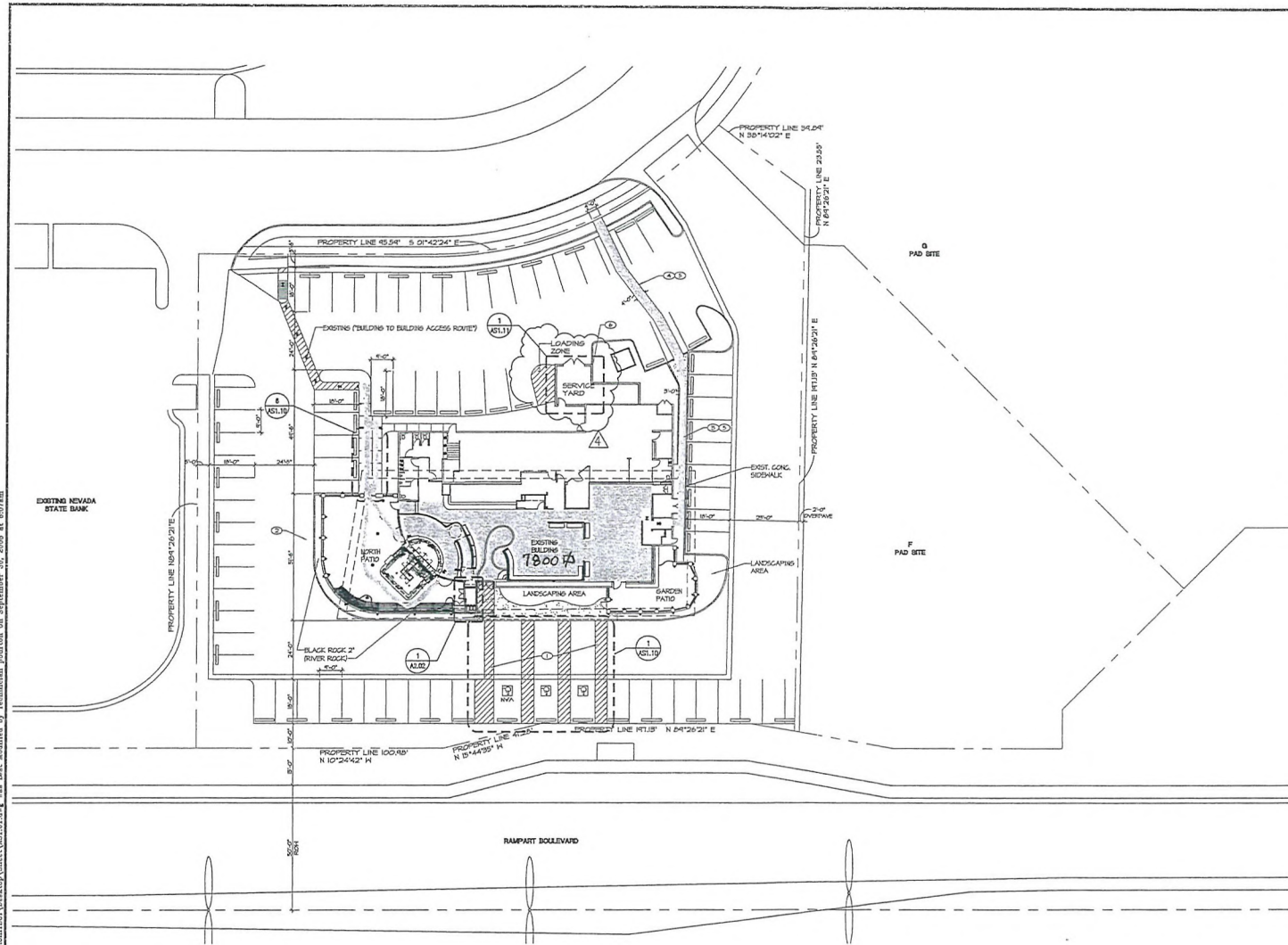

1. NEW LOCATION FOR ADA PARKING STALL.

- 74 TOTAL STALLS (ON PROPERTY)

2. NEW BUILDING TO BUILDING ACCESS ROUTE.

3. NEW SLOPED CONCRETE SIDEWALK, UNIFORM SHAPE FROM EXISTING SIDEWALK CONNECTION POINT TO TOP OF ASPHALT AT PARALLEL.

4. FENCE STAIRS TO MATCH EXISTING AT R.E. CORNER OF PROPERTY.

5. ACCESSIBLE ROUTE TO PUBLIC WAY WITH RAMPING SLOPE NOT EXCEEDING 8% OR CROSS-SLOPE NOT EXCEEDING 2%.

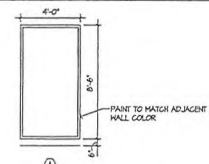

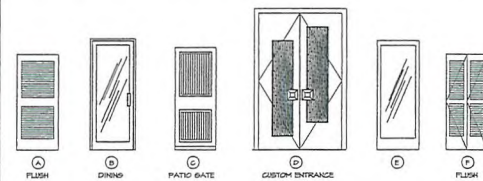
