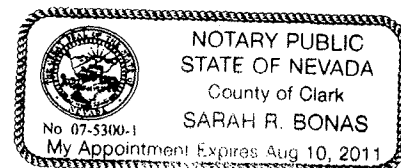

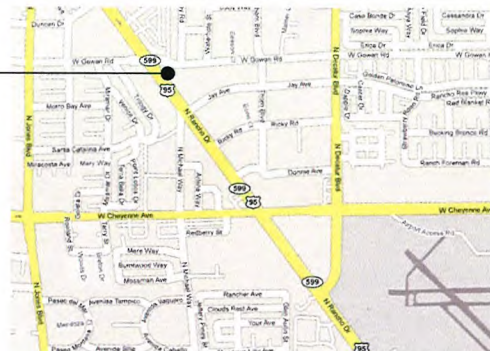

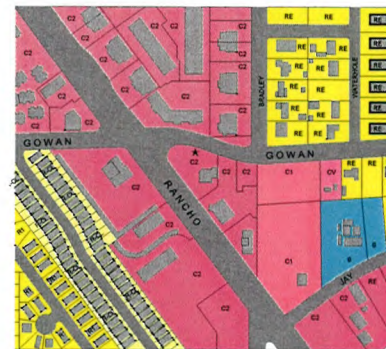

VICINITY MAP



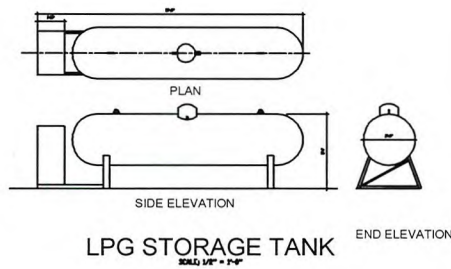
CURRENT ZONING

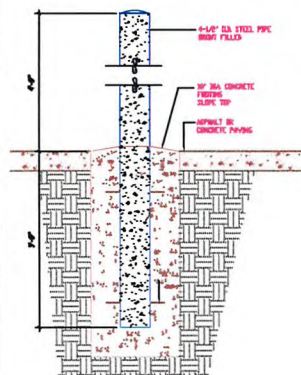

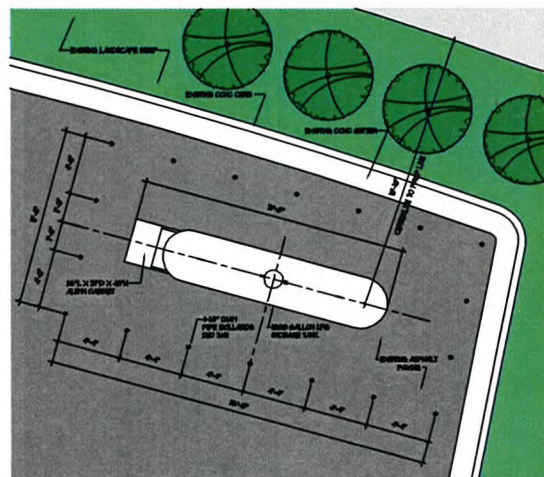
LPG STORAGE TANK

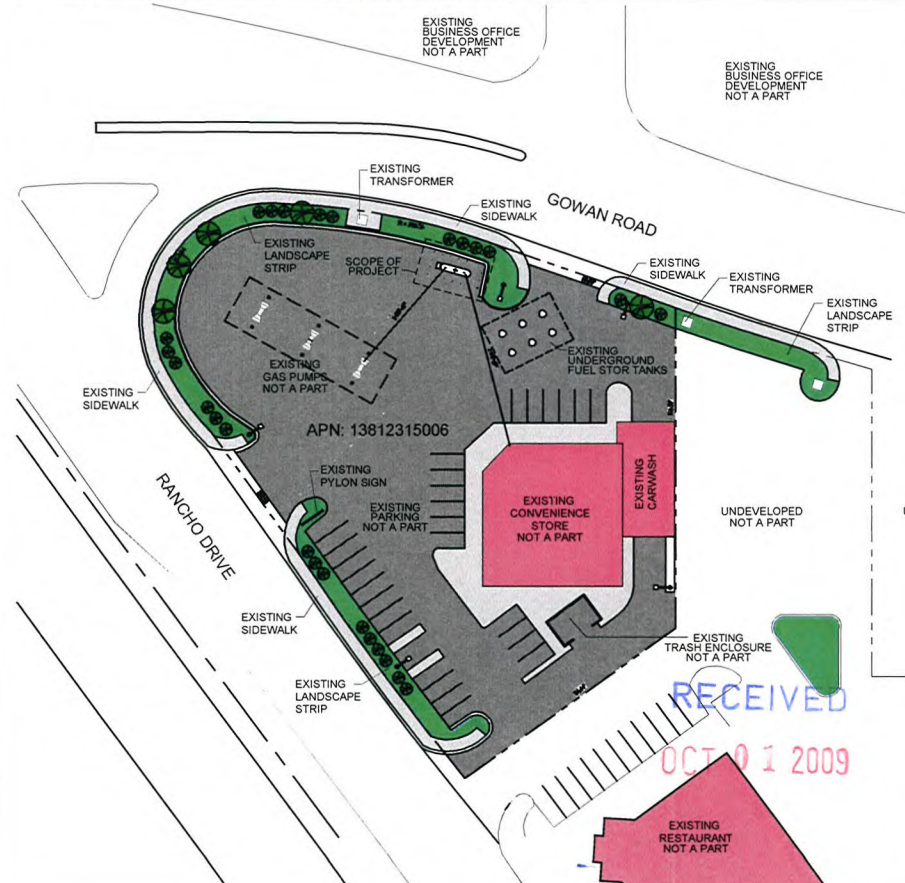
