Minutes:

CHAIR TROWBRIDGE declared the Public Hearing open.

FLINN FAGG, Planning and Development, indicated that the Text Amendment is intended to bring the zoning code into conformance with the Nevada Revised Statutes (NRS) relative to regulations applied to mopeds. A definition of moped has been added that is consistent with NRS and with the Department of Motor Vehicles (DMV). Mopeds may be sold under a general retail license but they do not fall into the category for motorcycle or automobile sales. It clarifies that a moped has an engine size of 50cc or less. Staff recommended approval.

COMMISSIONER TRUESDELL asked if anything within the Text Amendment would allow for general retail uses as a service provider. MR. FLINN replied that service falls under a different

category and they have to conform to the requirements. They would have to go into the appropriate zoning district in order to provide service. Staff recommended approval.
