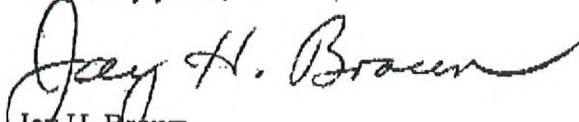
Dear Ms. Wheeler:
