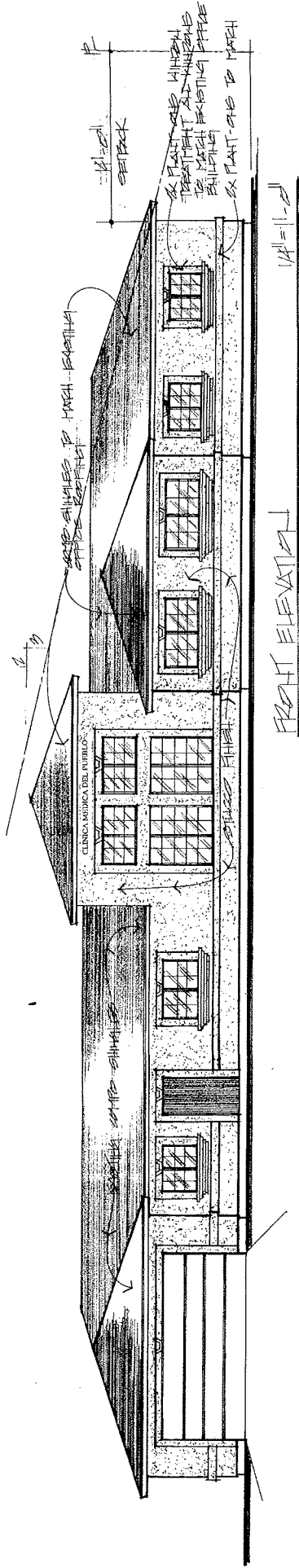

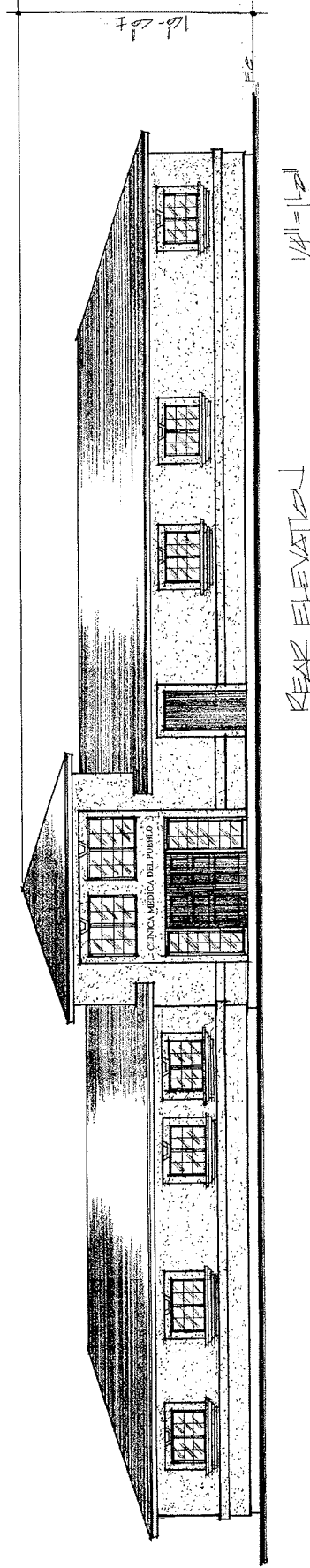

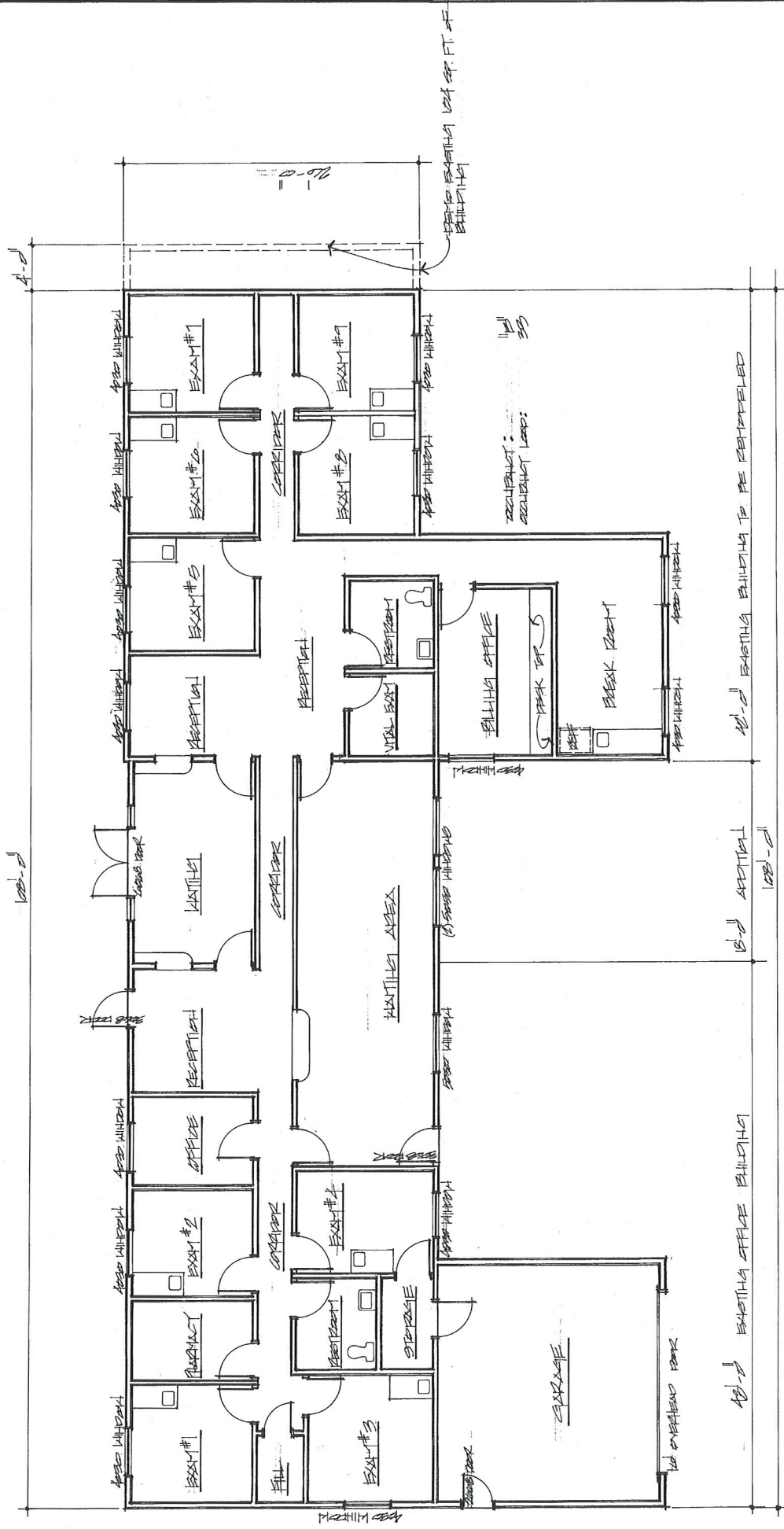
FRONT ELEVATION
