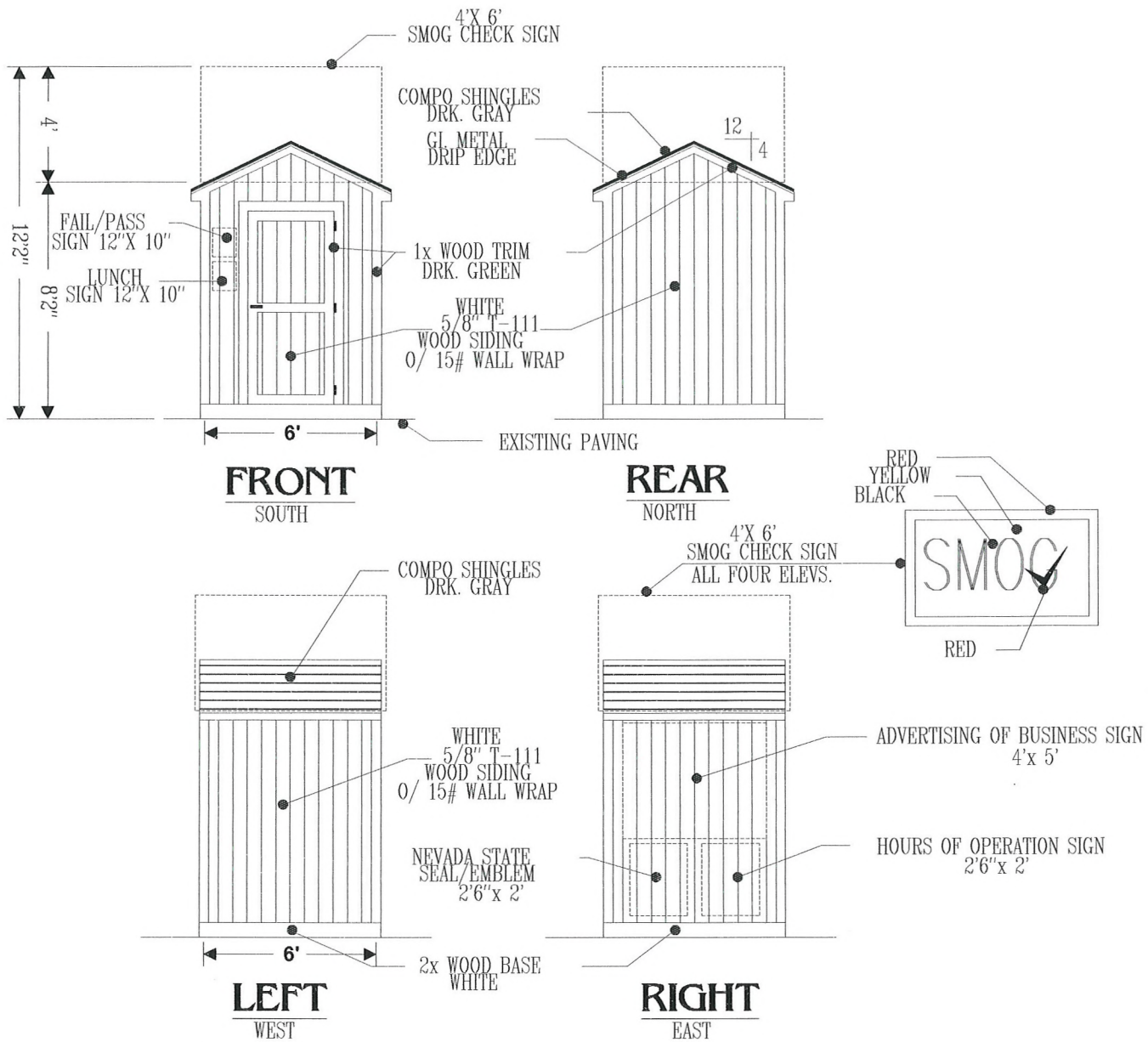

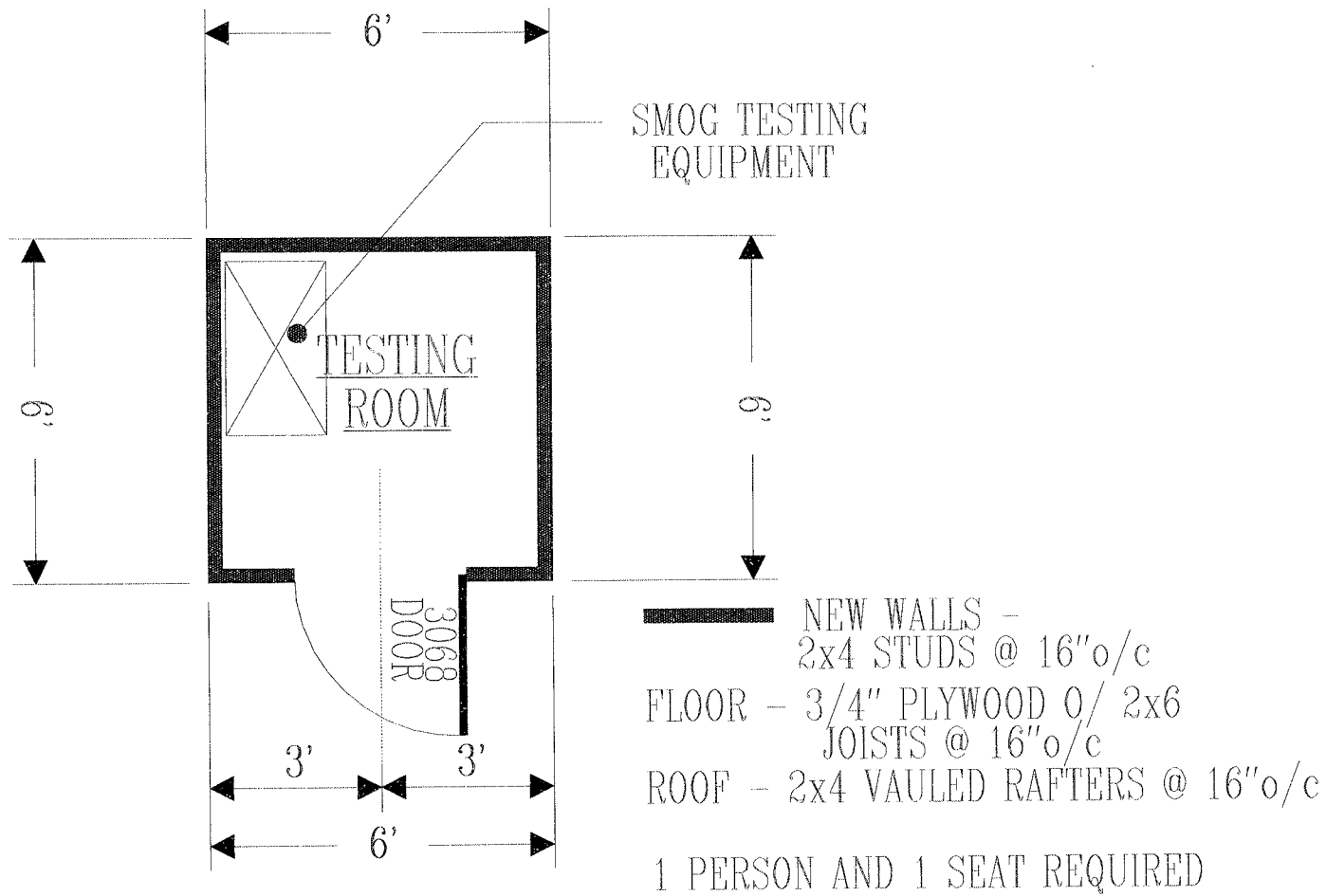


EXTERIOR ELEVATIONS
