I am writing on behalf of Walgreen Co. concerning its special use permit application to add accessory package liquor off-sale to the existing Walgreens at 8500 West Cheyenne Avenue (APN #138-08-811-004). The application is scheduled for hearing before the City of Las Vegas Planning Commission on Thursday, April 22, 2010. Although the application was amended to increase the square footage of the use to 79 square feet shortly before notice was mailed, the item currently lists the use as being 48 square feet.

Accordingly, Walgreens respectfully requests that SUP-37580 be held until the May 27, 2010, Planning Commission meeting in order to re-notice at the increased square footage amount. Enclosed is a check in the amount of \$500.00 payable to the City of Las Vegas for notice fees.

Please note that the company is in the process of removing the on-site storage containers and expects to have this completed before the May 27 meeting.
