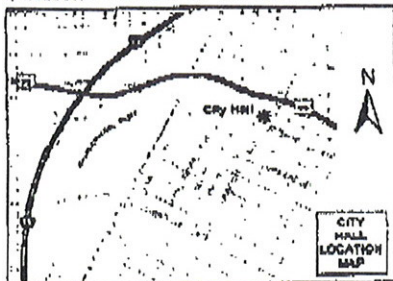

The proposed request makes unauthorized use of land at 215 N. Third Street (Ace Loan Company) owned by B F Trust. Ace Loan Company is operated by the trustees of B F Trust (Howard and Caryl Bock). B F Trust owns the entire lot at 215 N. Third Street, which extends easterly to the middle of Third Street. The scant information available to B F Trust at this time indicates a taking of the parking area in front of Ace Loan for taxi stands and bus stops, which would be harmful to Ace Loan's business and customer access. Other aspects of the request not yet known to B F Trust may adversely impact the business of Ace Loan Company. The applicant has not given B F Trust even the courtesy of discussing the request. In all fairness to B F Trust, consideration of the request should be delayed for a time sufficient for B F Trust to acquaint itself further with the request, its plans and its possible impact on the operations of Ace Loan Company.

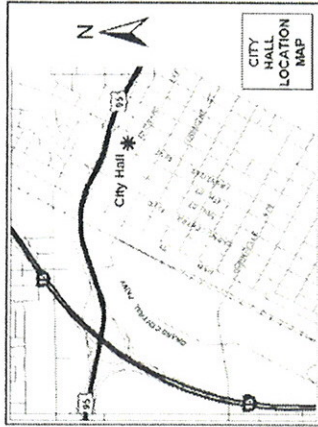
