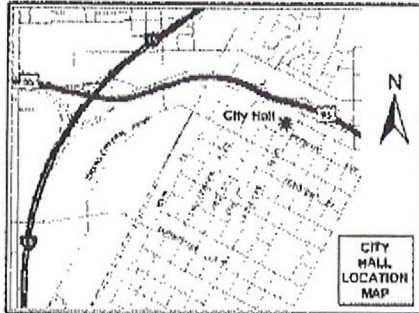
Please, please focus on real improvements along the LV Blvd corridor which will be both inviting to the tourists as well as purposeful to the surrounding residents.

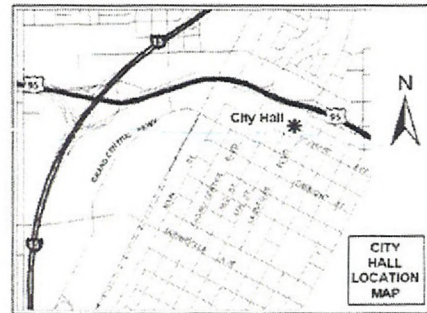

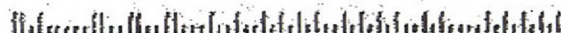
