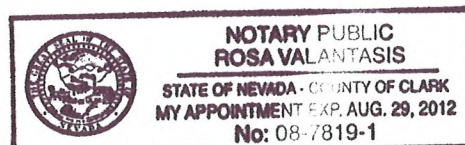

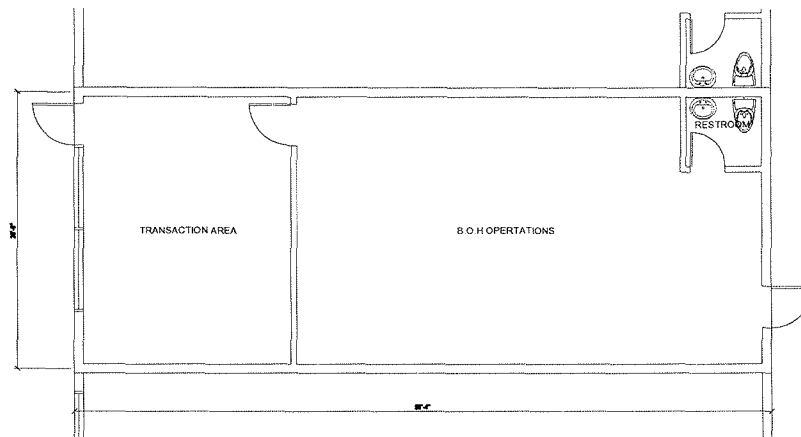

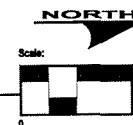


1 FLOOR PLAN
