Dear City Council:

As per the attached form, I OPPOSE the Special Use Permit for Foster Day Car Wash for several reasons:

1. The extreme noise from the actual car wash equipment.
2. The extreme noise from car stereos.
3. The extreme noise from people talking and kids screaming.
4. The lack of privacy when in my own back yard. The few new trees are short and planted fifteen feet apart, providing no sound or visual barrier.
5. The few "mature" trees do not provide a visual or a sound barrier.

However, the pinecone needles from the mature trees do blow into my back yard and swimming pool almost daily, costing me \$1500 a year for weekly cleanup.

If a ten foot tall block wall was constructed, providing privacy, sound and visual protection for my family, I would not oppose the request the Special Use Permit.

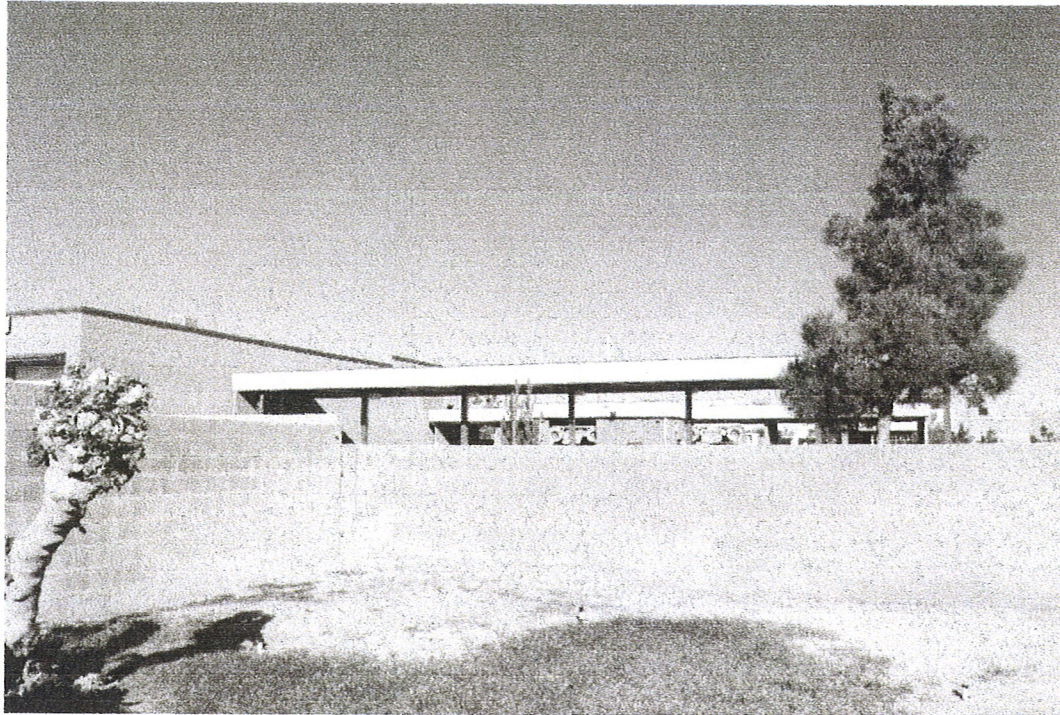

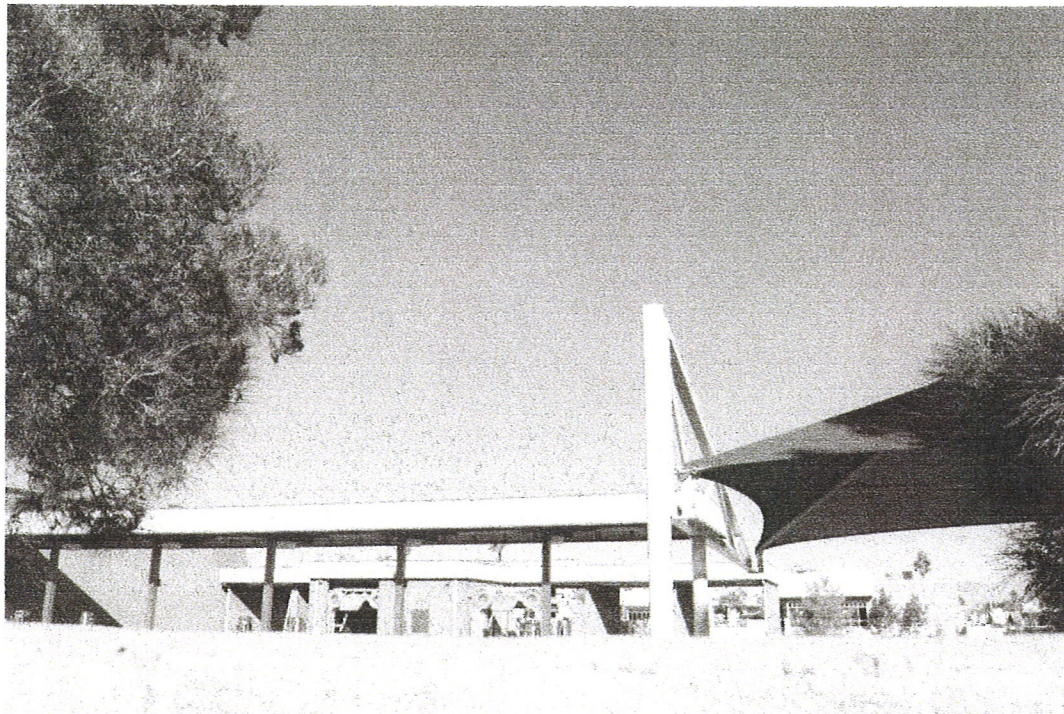
