3 AN ORDINANCE TO UPDATE THE MUNICIPAL CODE PROHIBITION REGARDING THE
4 POSSESSION OF FALSE IDENTIFYING INFORMATION OR DOCUMENTATION, AND TO
5 PROVIDE FOR OTHER RELATED MATTERS.

7 Summary: Updates the Municipal Code
8 prohibition regarding the possession of false
9 identifying information or documentation.

10 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
11 AS FOLLOWS:

12 SECTION 1: Title 10, Chapter 30, Section 40, of the Municipal Code of the City of
13 Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

14 **10.30.040:** It is unlawful for [any person to knowingly use or attempt to use any false, fraudulent,
15 misleading or fictitious identification material for the purpose of obtaining any privilege, benefit or
16 gratuity whatsoever.] a person to possess any document or personal identifying information for the
17 purpose of establishing a false status, occupation, membership, license or identity for himself or any
18 other person or for any other benefit or gain.

19 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or
20 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
21 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
22 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
23 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
24 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
25 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
26 invalid or ineffective.

27 SECTION 3: Whenever in this ordinance any act is prohibited or is made or declared
28 to be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is
29 required or the failure to do any act is made or declared to be unlawful or an offense or a
30 misdemeanor, the doing of such prohibited act or the failure to do any such required act shall

1 constitute a misdemeanor and upon conviction thereof, shall be punished by a fine of not more than
2 \$1,000.00 or by imprisonment for a term of not more than six months, or by any combination of such
3 fine and imprisonment. Any day of any violation of this ordinance shall constitute a separate offense.

4 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,
5 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
6 1983 Edition, in conflict herewith are hereby repealed.
