Due to current economic conditions and the projected revenues for Fiscal Year 2011, it is not possible for the City to balance the budget without a reduction in the scheduled cost of living adjustment. The MOU allows for scheduled raises to be reduced by 1% based on the same limit increase in the average compensation of the executive and appointive employees. Per section 2 of the MOU this will decrease the COLA from 3% to 2%, which equates to a cost avoidance of \$1,124,000.00.
