**PURPOSE/BACKGROUND:**

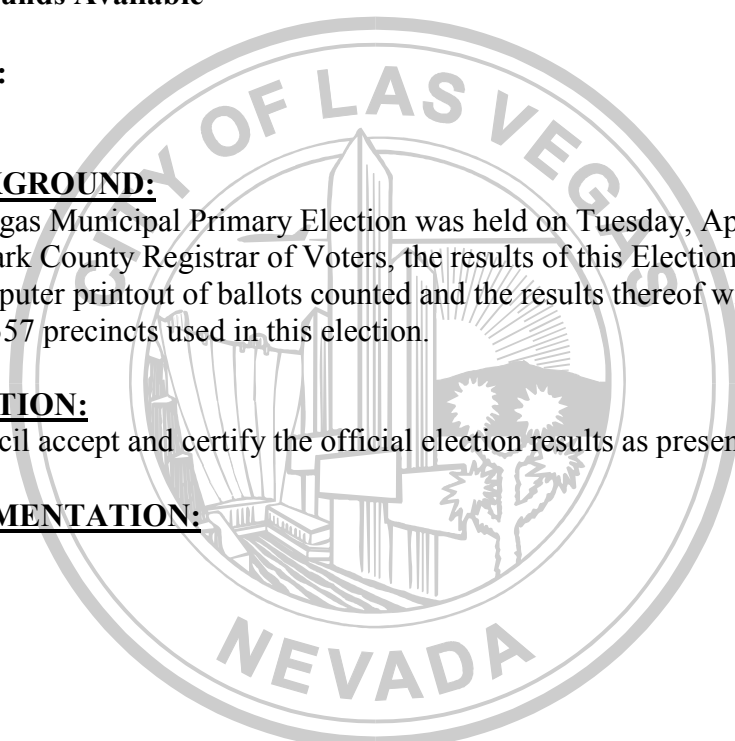
