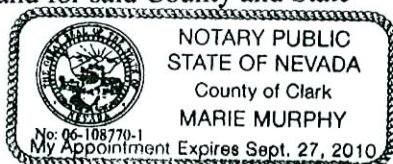

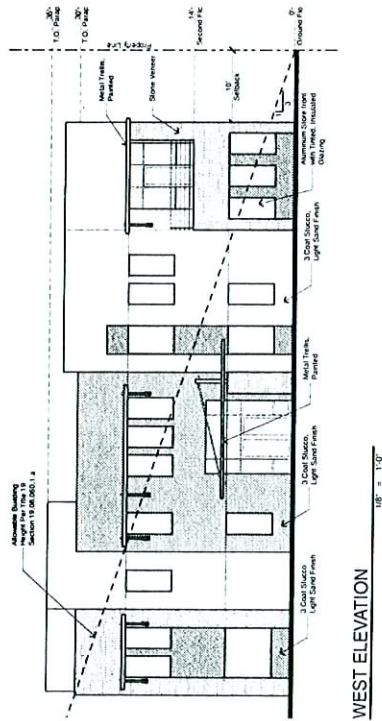

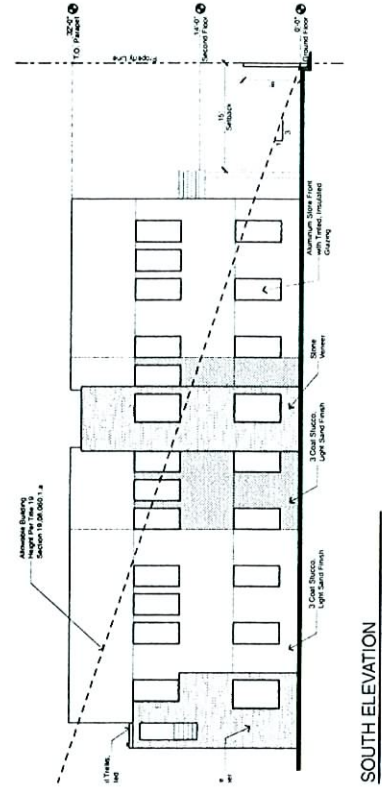

WEST ELEVATION

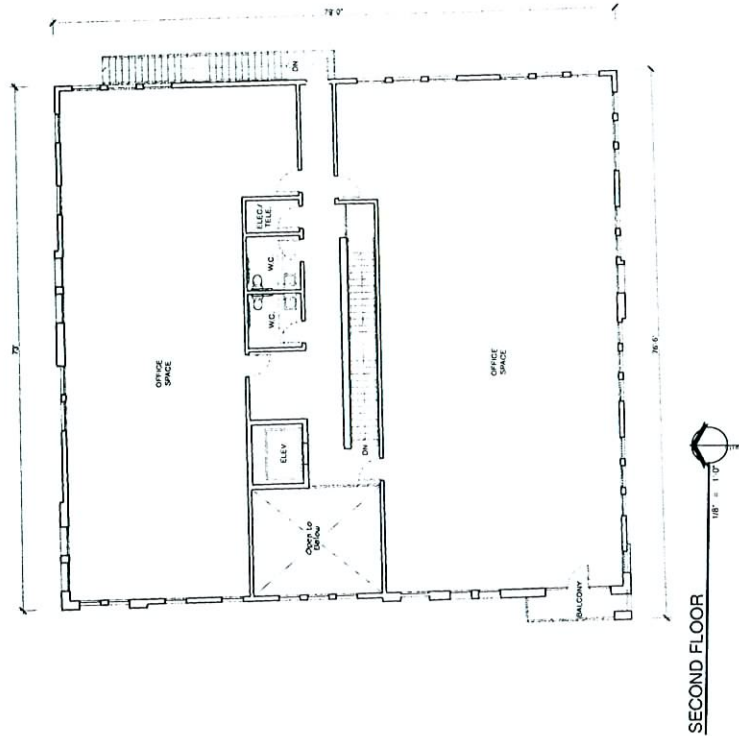


SOUTH ELEVATION
