ZON-20192-for PD15 must NOT be used for the intent of being "home" to fellow residents of this ward. Have any of you, councilpersons/planning commissioners, been to observe that locale?
Too few neighborhood services (parks/stores),
too little access (1 in/2 out ONLY on 30th St.),
too little emergency access (private roads 13 feet more narrow than required),
too high density (many 2 story apt. complex adjacent to the West),
too little air/visual space (aprox. 6-8 story embankment of US95-515 and industrial bldgs),
too little open/green space (1/20th of required space requested),
too many people for the space (56 THREE STORY units planned),
too confusing proposals (RPD 14 minimum in letter from PE, MSE Joe Haun, but RPD 15 under ZON-20188!),
too much stretch of imagination for "lofts" (how about cubicles?),
too demeaning a plan for a resident to feel respected and raise healthy children (although under a large bill board of our honorable mayor,
too short is this list because disgusting is a 'kind' description of items 50-55 (surely our council persons are human AND humane owners of U. Lofts).

REMINDER~~ commercial to 15 units per acre?

allow 24'w. streets where 37' is required?

allow 3.98 acres where 5 acres MIN is required?

allow 2,059 sq ft Open Space where 40,249 is required?

allow 56 THREE STORY units on 3.98 acres?
