Minutes:

MAYOR GOODMAN declared the Public Hearing open on Items 145-147.

PASTOR ROGER BANNEMAN, 1109 Cold Stream Drive, appeared with TIM STEVENSON, 1725 Elderberry Drive, and agreed to conditions on Items 145 and 146 but requested a change on Item 147. PASTOR BANNEMAN believed the entry way was required to be 100 feet; however, the requirement is only for 36.6 feet. Thereafter, the site plan was revised to accommodate additional parking to compensate for the difference and the angled parking is now parallel parking.

CITY COUNCIL MEETING OF: MAY 16, 2007

COUNCILMAN REESE expressed concern with the landscape waiver for the north buffer property line; he directed staff to work with the applicant to ensure that the development is cohesive and there is integration into the trail system.

BEATRICE TURNER expressed concern for the landscaping waiver. COUNCILMAN REESE reiterated that he has directed staff to work with the applicant regarding landscaping.
