Minutes:

MAYOR GOODMAN declared the Public Hearing open on Items 160 and 29.

FRANCES BILLOF, 1001 South Valley View Boulevard, appeared on behalf of the applicant for Item 160. ATTORNEY ALICIA ASHCRAFT, Jolley Urga with Woodbury and Standish, appeared on behalf of the applicant on Item 29.

CITY ATTORNEY BRAD VERBIC stated that Item 29 is in order. Regarding Item 160, the goal is to ultimately change the code to accommodate the supper club license for a C-V (civic) use. He asked Council to approve the special use permit for 125 days, which will give sufficient time for the code to be changed. In addition, the license should be limited to beer and wine only, and the hours of operation should be 10:00 a.m. to 10:00 p.m.

COUNCILWOMAN TARKANIAN stated the project is unique and will be the jewel within the City. Regarding Item 29, she pointed out that this will be a four-day approval.

TIM McGARY, 200 Canyon, expressed concerns only with special events and the hours of operation for these events.

MARGO WHEELER, Director of Planning and Development, read the conditions into the record.

MAYOR GOODMAN declared the Public Hearing closed on Items 160 and 29.
