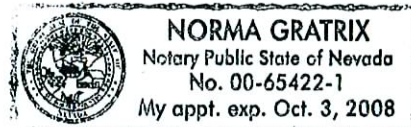

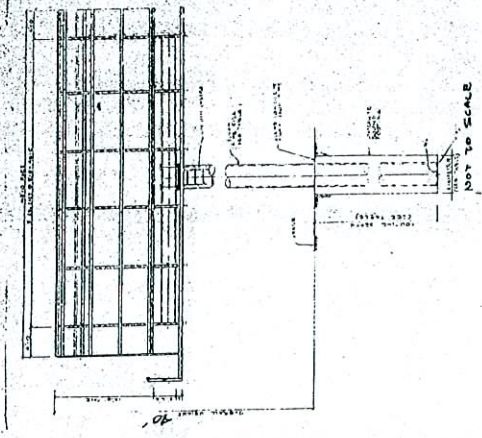


TRUCKMASTERS

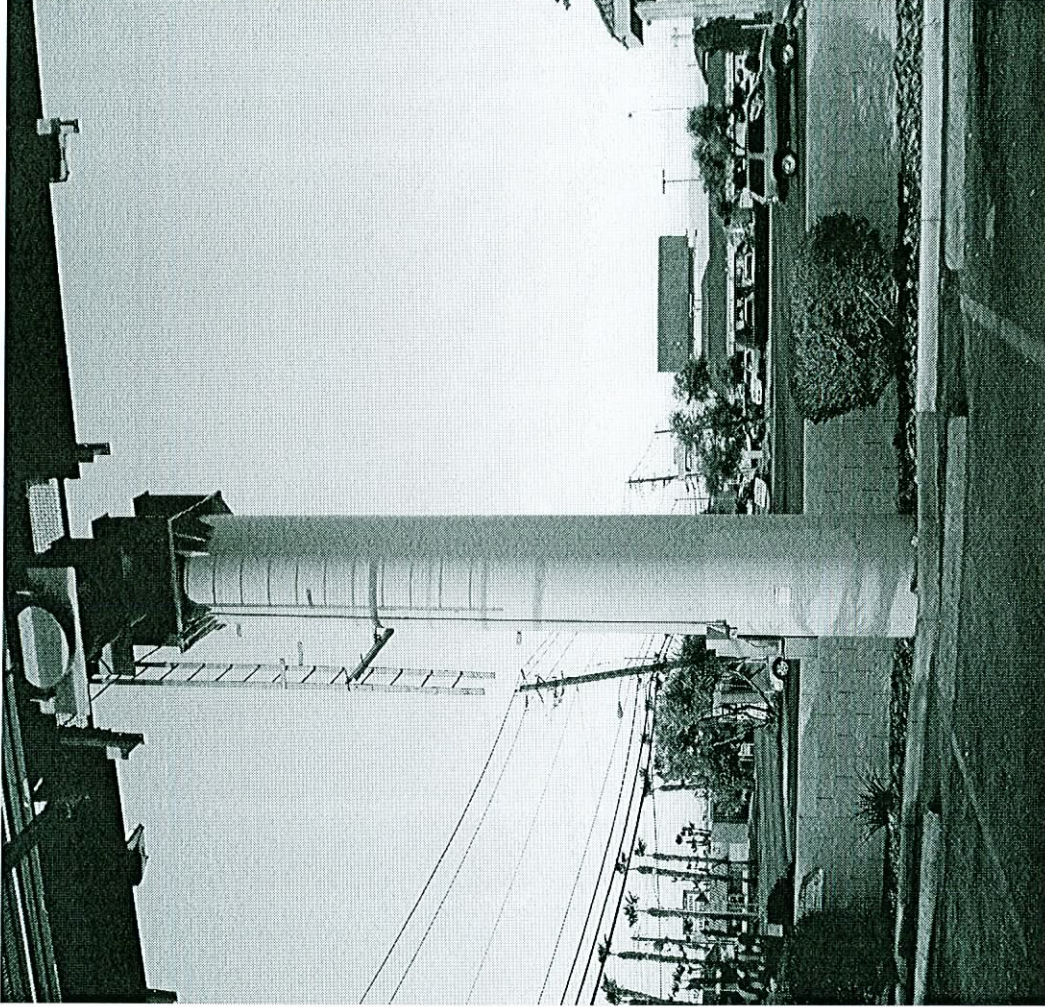
