PURPOSE/BACKGROUND:

The Senior Citizens Law Project is currently a City-sponsored program that has operated since 1978, providing legal assistance and support to over 100,000 senior citizens aged 60 and over free of charge. In 2011, the City of Las Vegas determined that due to significant budgetary constraints, the City can no longer maintain the Senior Citizens Law Project as a City-sponsored service program, but supports the Senior Citizens Law Project in its transition from a City-sponsored service program to an independent non-profit operation known as the Southern Nevada Senior Law Program, a duly-registered Nevada non-profit organization with IRS 501(c)(3) status pending by July 1, 2012. In eliminating the program, the City must also dissolve the Senior Citizens Project Advisory board, as it is no longer needed.

NOW, THEREFORE, IN ACCORDANCE WITH THE FOREGOING, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA, that the Senior Citizens Law Project Advisory Board is hereby dissolved, and Resolution R-1101-1978 hereby repealed.
