3 AN ORDINANCE TO READOPT THE MUNICIPAL CODE PROVISION MAKING STATE-LAW
4 MISDEMEANORS CITY MISDEMEANORS IF COMMITTED WITHIN THE CITY.

5 Proposed by: Bradford R. Jerbic, City Attorney Summary: Readopts LVMC 10.02.010 to make
6 State misdemeanors City misdemeanors if
committed within the City.

7 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
8 AS FOLLOWS:

9 WHEREAS, the Charter of the City of Las Vegas declares that any offense made a
10 misdemeanor by the laws of the State of Nevada shall also be a misdemeanor in the City of Las Vegas
11 whenever such offense is committed within the boundaries of the City; and

12 WHEREAS, the City Council has reaffirmed that declaration by means of the adoption
13 of LVMC 10.02.010; and

14 WHEREAS, a number of criminal laws were enacted or amended by the Nevada
15 Legislature during its 77th Session, some of which became effective upon passage and approval, and
16 others of which become effective upon October 1, 2013, or upon some other date specified within
17 those laws; and

18 WHEREAS, the City Council desires by this Ordinance to readopt LVMC 10.02.010
19 to include within its purview, to the extent affirmative action to do so is necessary, all the State
20 misdemeanor laws which have been enacted by the Nevada State Legislature.

21 NOW, THEREFORE, BASED UPON THE FOREGOING, THE CITY COUNCIL OF
22 THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:
