ITEM DESCRIPTION: For possible action regarding HPC Centennial Legacy grant application from Sarann Knight Preddy in the amount of \$5,000.00, Ward 5 (Barlow)

BACKGROUND

- 02/27/08 HPC approved Centennial project budget and timeline.
- 03/26/08 HPC requested revisions to the draft Centennial grant application.
- 05/28/08 HPC voted to review grant applications bi-annually in February and August, and vote bi-annually on grant awards in March and September.
- 08/28/13 HPC accepted the HPC Centennial Legacy grant application from Sarann Knight Preddy in the amount of \$5,000.00 for consideration at the September 25, 2013 HPC meeting.

ANALYSIS

Sarann Knight Preddy, a private citizen, has submitted an HPC Centennial Legacy Fund application for \$5,000.00 for the following:

- Conduct a seminar about the history of the Historic Westside.
- Hire a writer, photographer, videographer and designer to create a publication about the history of the Historic Westside.
- Costs associated with publishing the book.

At the August 28, 2013 HPC meeting, the commission had the following comments:

- Is the video and photographic documentation only for the panel discussion or will there be individual oral histories, interviews, etc. that will be documented?
- Who is the videographer, photographer and writer, and do they have experience with this type of project? Specifically, the commission would like to see someone with experience with recording oral histories or historic subject matter.
- Who will publish the book?
- What is the final format of the book or end product? For example, will the book be similar to the Historic Westside School book recently published by the Historic Westside School Alumni Foundation (a collection of stories and images submitted by alumni), or will it be a scholarly history book about West Las Vegas?
- The commission would like to see a cost estimate submitted by the proposed videographer, photographer and writer.

Ms. Preddy has submitted additional information regarding videographer Marlene Adrian, including detailed fees and previous projects (see attached).

Sarann Knight Preddy has not received funding from the HPC Centennial Legacy Fund.

PART II. Grant Description

How will the award funds be used?

Funds will be used to invite a panel of persons who have lived in Las Vegas more than 65 years who know the real history of the West Las Vegas. In a one day seminar the panelist will be engaged in a question and answer session with a moderator to discuss important events as they remember them. They will be asked about the impact of segregation on their lives, buildings, events and people who they believe should be noted in history. Early West Las Vegas history has been depicted negatively, however this panel will bring photos and stories that have never been told to give a complete first hand account of what really happened. The panel will be given a tour of West Las Vegas in order to bring back the memories and the stories will be recored for publication.

What is the historic significance of your project/activity to the city of Las Vegas?

The Historic Westside (Bonanza to Owens, A to MLK-Highland) has the largest concentration of African Americans in Las Vegas. This area was segregated from the rest of the City by forcing blacks to live on the Westside of the Union Pacific Railroad tracks without water and sewer. People lived in very poor conditions. Blacks were denied decent jobs on the strip, denied basic priviledges, and suffered indiginties that have not been documented. The youth, today, need to learn about this history so that they can better understand why the conditions exist today. The purpose of the publication is to document this history for the betterment of future generations.

I will spend the fall collecting the information, pictures and support for the project then in the winter I plan to publish the book in time for Black history month

There will be two main parts of the book. The working title of the book is "71 Years in Las Vegas". I plan to tell my story and invite 20 people who have lived in Las Vegas more than 65 years to help me. I will engage a moderator/facilitator in a panel discussion which will be videotaped and recoreded in photographs. The second part of the book will be a collection of stories that my friends and associates will write about me. I am asking 100 people to write a one page story about their association me with. When complete the stories will be compiled in the book.

Sarann Knight- Preddy

"A Pioneer Who Became an Icon in the World Of Gaming"

Sarann Knight-Preddy, a true gaming pioneer was the first "Woman of Color" to earn a Non Restricted Gaming License in the State of Nevada and the world.

More than half a century ago, Mrs. Preddy embraced the spirit of gaming in Las Vegas, Nevada. Realizing the potential of gaming in its infancy, she obtained her first gaming license in 1950 and invested in a number of gaming businesses outside of Las Vegas, including the Club Tonga Casino and the Lincoln Bar in Hawthorne, Nevada.

As a result of her interest in gaming, she made frequent trips to Las Vegas. After visiting the newly-opened Moulin Rouge in 1955, the only non-segregated casino in Las Vegas which drew headliners such as the Mills Brothers, Jack Benny, George Burns, Gracie Allen, Nat "King" Cole and Sammy Davis, Jr., she decided to move back to Las Vegas and make her mark in the gaming industry.

Mrs. Preddy began her gaming ascent in Las Vegas when she acquired the popular People's Choice Casino, the Playhouse Lounge and several other businesses. Her most prized acquisition was the Moulin Rouge. Along with her son, James Walker, and husband, Joe Preddy, she set out to restore the glitz and glamour of the legendary casino by taking over in 1985, and a few years later, she purchased the Moulin Rouge and remained there until 1998. During that time she became the first "woman of color" to hold a non-restricted gaming license, the same license issued to major casinos on the Las Vegas Strip. By 1994, Mrs. Preddy succeeded in having the Moulin Rouge declared a historic landmark.

She has a distinguished history of services to the community, such as civic, charitable, youth and business organizational programs. Mrs. Preddy organized the Las Vegas Democratic Club and the Nevada Black Chamber of Commerce and became its first president. She has been involved in numerous boards; Nevada Motion Pictures Commission, Central Democratic Committee, National Voters League and the Las Vegas Black Historic Society. She served five times as Chair of the Ebony Fashion Fair and Basileus (President) of Gamma Phi Delta Sorority, and she has volunteered for numerous charities such as the Heart Fund and Easter Seal Drive. She continues to work toward bringing the Westside of Las Vegas back to its splendor.

A native of Eufaula, Oklahoma, Ms. Preddy is a mother, grandmother and great grandmother and an active member of Second Baptist Church. She attended business college in Los Angeles, California and the Southern Nevada University in Las Vegas, Nevada, where she studied business, cosmetology and real estate.

Mrs. Preddy has received countless awards and accolades for her many contributions. Her numerous recognitions include Proclamations from the City of Las Vegas and the Clark County Commission, the Hadassah Jewish Pin (the highest honor bestowed on a non-Jewish person); she was named Woman of the Year by the Greater Las Vegas Chamber of Commerce. She has received awards from the Clark County School District and the NAACP. In 2005, she was honored in a documentary, "The First Woman of Color in Gaming" at the Orleans Casino.

Nothing could more exemplify the character of Sarann than her attitude and conduct at the lost of the commissioner's race when she learned the conclusion of the city election's final returns. Tally of several late reporting precincts tipped the balance in favor of the incumbent Commissioner making him the victor by a scant margin of 73 votes. The disappointment of Sarann's campaign workers was expressed in words tinged with chagrin bitterness, even acrimony-expressions typical of the individual speaker. But for Sarann Knight Preddy, the whole effort was accorded, the same regard as all other worthwhile community programs with which she became involved and the fact that the campaign did not culminate in victory caused her no visible pain or distress and certainly left her with no vantage of bitterness. Neither did it, for one single moment, deter her absorption in a long range of civic and community activities.

Sarann Knight Preddy is recognized as Las Vegas' most prominent "people", person. For more than 60 years, she has been involved as a volunteer worker in every aspect of community activities which are programmed to help people.

On May, 2010, she received a Honorary Doctorate Degree from UNLV and on May 25th, she was honored with the Sarann Knight Apartments building in West Las Vegas. She was recently inducted in the Smithsonian Institute, and was honored by the Who's Who in Black Las Vegas and the Sophisticate's Black Hair. The list of achievements goes on and on, too many to mention, but a list of more accolades and awards are available upon request.

Sarann Knight-Preddy is a true Las Vegas Pioneer and have definitely paved the way for us all. This city and the world is a better place because of Sarann Knight-Preddy, and for her achievements, dedication and for all of her service in the community, we say; "Thank You Sarann", and may God bless you always.
