4 VEGAS 2020 MASTER PLAN, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Adopts an updated Parks and
Recreation Element of the Las Vegas 2020
Master Plan.

7 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS
8 FOLLOWS:

9 SECTION 1: The document entitled "Parks and Recreation Element," the essential
10 contents of which were approved by the City Council on November 20, 2013, is hereby adopted as a part of
11 the Las Vegas 2020 Master Plan and is incorporated therein by this reference. That document shall
12 function as a portion of the recreation plan within the recreation and open space element of the Las Vegas
13 2020 Master Plan and shall replace and supersede any previously-adopted parks and recreation element or
14 inconsistent provision of the City's General Plan, as adopted by Ordinance No. 3636 and amended
15 thereafter.

16 SECTION 2: The Department of Planning is authorized and directed to:

17 (A) Include the date of the adoption of this Ordinance within or upon the document
18 referred to in Section 1 at such locations as are designed to reflect the date of the adoption of this
19 Ordinance;

20 (B) Publish the document in final form; and

21 (C) File the final document with the City Clerk.

22 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or
23 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
24 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
25 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City
26 of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph,

1 sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections,
2 subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

3 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,
4 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983
5 Edition, in conflict herewith are hereby repealed.
