As part of a recent ordinance updating the City's alcoholic beverage regulations, the City Council adopted a provision authorizing the owner of an establishment adjacent to a pedestrian mall that holds a license for nonrestricted gaming and a tavern license at the same location to operate a temporary or permanent bar upon the mall. This bill clarifies the intent of that provision: to allow one or more such bars to be established rather than establishing a limitation of one bar only.

10 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS
11 FOLLOWS:

12 SECTION 1: Ordinance No. 6266 and Title 6, Chapter 50, Section 285, of the Municipal
13 Code of the City of Las Vegas, Nevada, 1983 Edition, are hereby amended so that Section 6.50.285 reads
14 as follows:

15 **6.50.285:** (A) Notwithstanding any provision in this Chapter to the contrary, the owner of an
16 establishment adjacent to or within the pedestrian mall that holds a tavern license is authorized to sell
17 alcoholic beverages through a walk-up window that faces a street alignment within the boundaries of the
18 pedestrian mall, except for the Casino Center Boulevard and 4th Street alignments. Prior to the placement
19 or construction of such window, a licensee shall comply with all requirements of the Director, the Building
20 Official and the Director of Public Works. Such window shall be considered another bar at the
21 establishment for purposes of this Chapter.

22 (B) Notwithstanding any provision in this Chapter to the contrary, the owner of an
23 establishment licensed to operate nonrestricted gaming that is also authorized to sell alcoholic beverages
24 upon the premises of that establishment pursuant to a tavern alcoholic beverage license may locate [a] one
25 or more temporary or permanent [bar] bars upon an adjacent pedestrian mall, provided that such bar or bars
26 [is] are directly adjacent to the premises of that establishment and upon the pedestrian mall. Prior to the

1 placement or construction of such bar or bars, a licensee shall comply with all requirements of the Director,
2 the Building Official and the Director of Public Works.

3 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or
4 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
5 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
6 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City
7 of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph,
8 sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections,
9 subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

10 SECTION 3 Whenever in this ordinance any act is prohibited or is made or declared to
11 be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is required
12 or the failure to do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of
13 such prohibited act or the failure to do any such required act shall constitute a misdemeanor and upon
14 conviction thereof, shall be punished by a fine of not more than \$1,000.00 or by imprisonment for a term of
15 not more than six months, or by any combination of such fine and imprisonment. Any day of any violation
16 of this ordinance shall constitute a separate offense.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: The corporate limits of the City of Las Vegas, Nevada, are hereby extended to annex, include, and make a part of the City of Las Vegas, Nevada, the following described real property:

That portion of the East Half (E 1/2) of the Southwest Quarter (SW 1/4) of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of Section 24, Township 19 South, Range 59 East, MDM, County of Clark, State of Nevada, being a portion of LOT 1 and a portion of Lot 2 of that CERTIFICATE OF LAND DIVISION, recorded February 22, 1989 in Book 890222 as Instrument 00985 of Clark County, Nevada Records, together with portions of those parcels of land described by GRANT, BARGAIN, SALE DEED, recorded February 22, 1989 in Book 890222 as Instrument 00968 of Clark County, Nevada Records, described as follows:

1 COMMENCING at the southwest corner of the Southeast Quarter (SE 1/4) of the

17 Records, said point also being a point on a non-tangent curve, concave southeasterly and
18 having a radius of 3175.00 feet, a line radial to said point bears North 53°12'26" West;
19 thence along said northeasterly projection and southwesterly along said curve through a
20 central angle of 00°54'44" and an arc distance of 50.55 feet to the northerly corner of said
21 EXHIBIT A-13 parcel, said northerly corner also being a point on a curve, concave
22 southeasterly and having a radius of 3175.00 feet; thence along the northwesterly line of
23 said EXHIBIT A-13 parcel and southwesterly along said curve through a central angle of
24 05°01'55" and an arc distance of 278.84 feet to the northwest corner of that parcel of land
25 described by EXHIBIT A-14 of said Dedication, said northwesterly corner also being a
point on a curve, concave southeasterly and having a radius of 3175.00 feet; thence along
the northwesterly line of said EXHIBIT A-14 parcel and southwesterly along said curve
through a central angle of 05°58'00" and an arc distance of 330.64 feet to the POINT OF
BEGINNING.

SECTION 2: The City Council hereby determines that the described territory
meets the requirements provided by law for annexation to the City for the following reasons:

A. The area to be annexed was contiguous to the City's boundaries at the time
the annexation proceedings were instituted;

B. More than one-eighth (1/8) of the aggregate external boundaries of the

1 area are contiguous to the City;

2 C. The territory proposed to be annexed is not included within the boundaries
3 of another incorporated city or within the boundaries of any unincorporated town as those
4 boundaries existed as of July 1, 1983;

5 D. The City is eligible to annex the described territory because the
6 landowners have signed a petition constituting one hundred percent (100%) of the owners of record
7 of individual lots or parcels of land within the annexation area.

8 SECTION 3: The City will provide police protection through the Las Vegas
9 Metropolitan Police Department, fire protection, street maintenance, and library services
10 immediately upon annexation. Garbage collection by the company franchised by the City will also
11 be provided immediately. The City sanitary sewer system will serve the proposed annexation area.
12 Any connection to or extension of this sewer line to serve the annexation area shall be at the
13 expense of the landowners. Other services, such as participation in the City's recreational
14 programs, special education classes and programs, public works planning, building inspections, and
15 other City services will also be available immediately. Utilities such as gas, electricity, telephone,
16 and water are provided by private utility companies and other services to the area will not be
17 affected by annexation. Street paving, curbs and gutters, sidewalks and street lights which are not
18 in place at the time of annexation will be installed in the presently developed areas upon the request
19 of the property owners and at their expense by means of special assessment districts. Such
20 improvements will be extended into the undeveloped areas as development takes place and the
21 need therefor arises, and will be located according to the needs of the area at that time. Such
22 installations will also be made at the expense of the property owners, either by means of special
23 assessment districts or as prerequisites to the approval of subdivision plats, building permits or
24 other land use or development applications.

25 SECTION 4: The annexation of the described territory shall become effective

1 on the 16th day of January, 2014, and on that date the City will have the funds appropriated in
2 sufficient amount to finance the extension into the described territory of police protection, fire
3 protection, street maintenance, street sweeping, and street lighting maintenance.

4 SECTION 5: The described territory, together with the inhabitants and property
5 thereof, shall, from and after the 16th day of January, 2014, be subject to all debts, laws, ordinances
6 and regulations in force in the City and shall be entitled to the same privileges and benefits as other
7 parts of the City, and shall be subject to municipal taxes levied by the City.

8 SECTION 6: The City Engineer is hereby instructed to cause to be prepared an
9 accurate map or plat of the described territory and to record the map or plat, together with a
10 certified copy of this ordinance, in the office of the County Recorder of Clark County, Nevada,
11 which recording shall be done prior to the 16th day of January, 2014.

12 SECTION 7: The described territory, which previously has been zoned R-U
13 (County of Clark classification), is hereby classified as U (City of Las Vegas classification), which
14 is deemed to be the City equivalent of the County classification.

15 SECTION 8: If any section, subsection, subdivision, paragraph, sentence, clause
16 or phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or
17 invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
18 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
