PURPOSE/BACKGROUND:

On December 17, 2013 Agreement 13.51111-TF was awarded by the Purchasing Manager. The scope of work includes preconstruction services associated with the installation of reinforced concrete boxes, junction structures and associated storm drain collection facilities in an area severely damaged by recent flooding. Based on the preconstruction engineering, the reinforced concrete boxes required for construction are a long-lead item with an estimated three-month fabrication period. This modification provides for the procurement of these boxes during the preconstruction phase, allowing the City to expedite installation of the boxes prior to flood season. Meadow Valley Contractors, Inc. is located in Las Vegas, Nevada.
