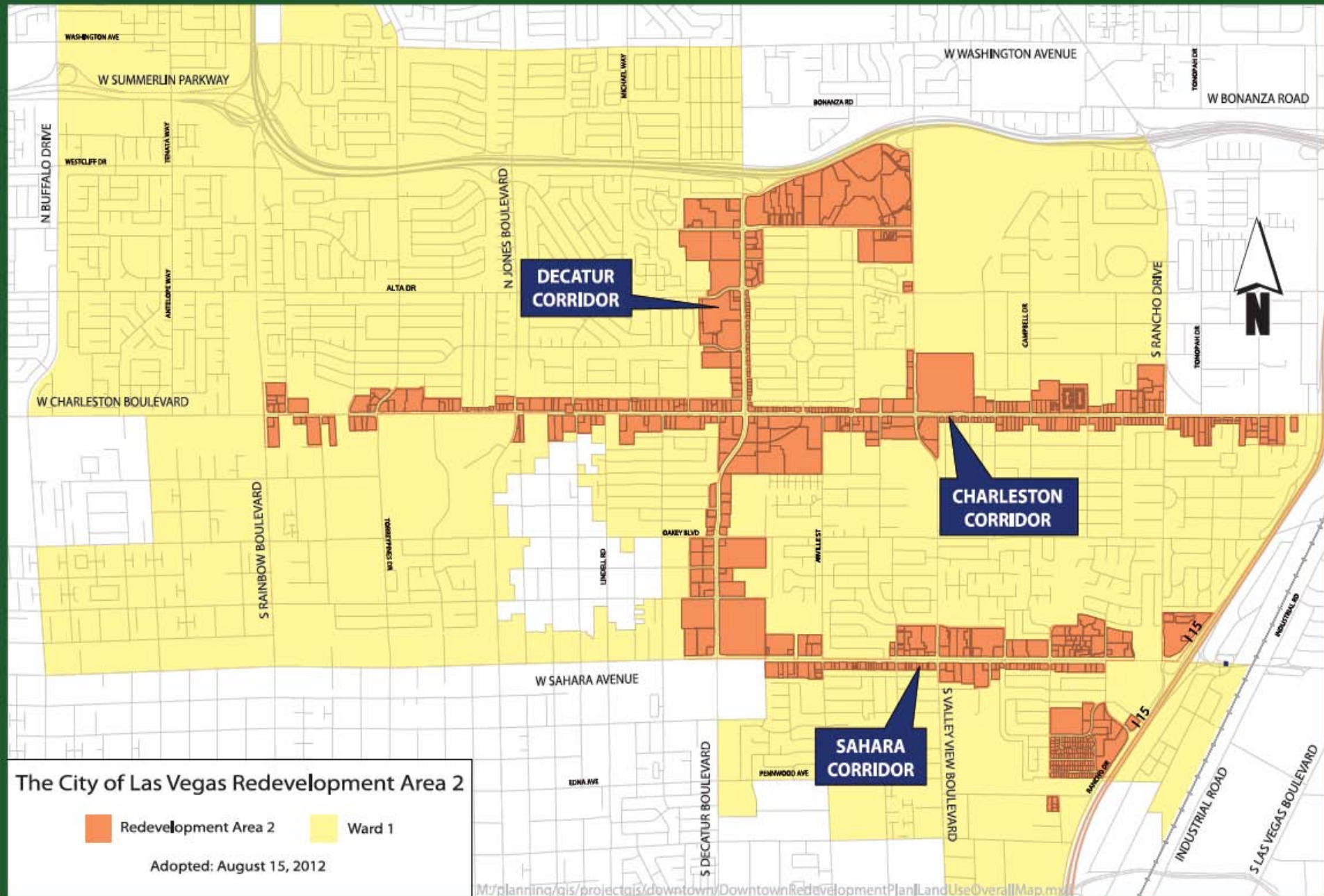

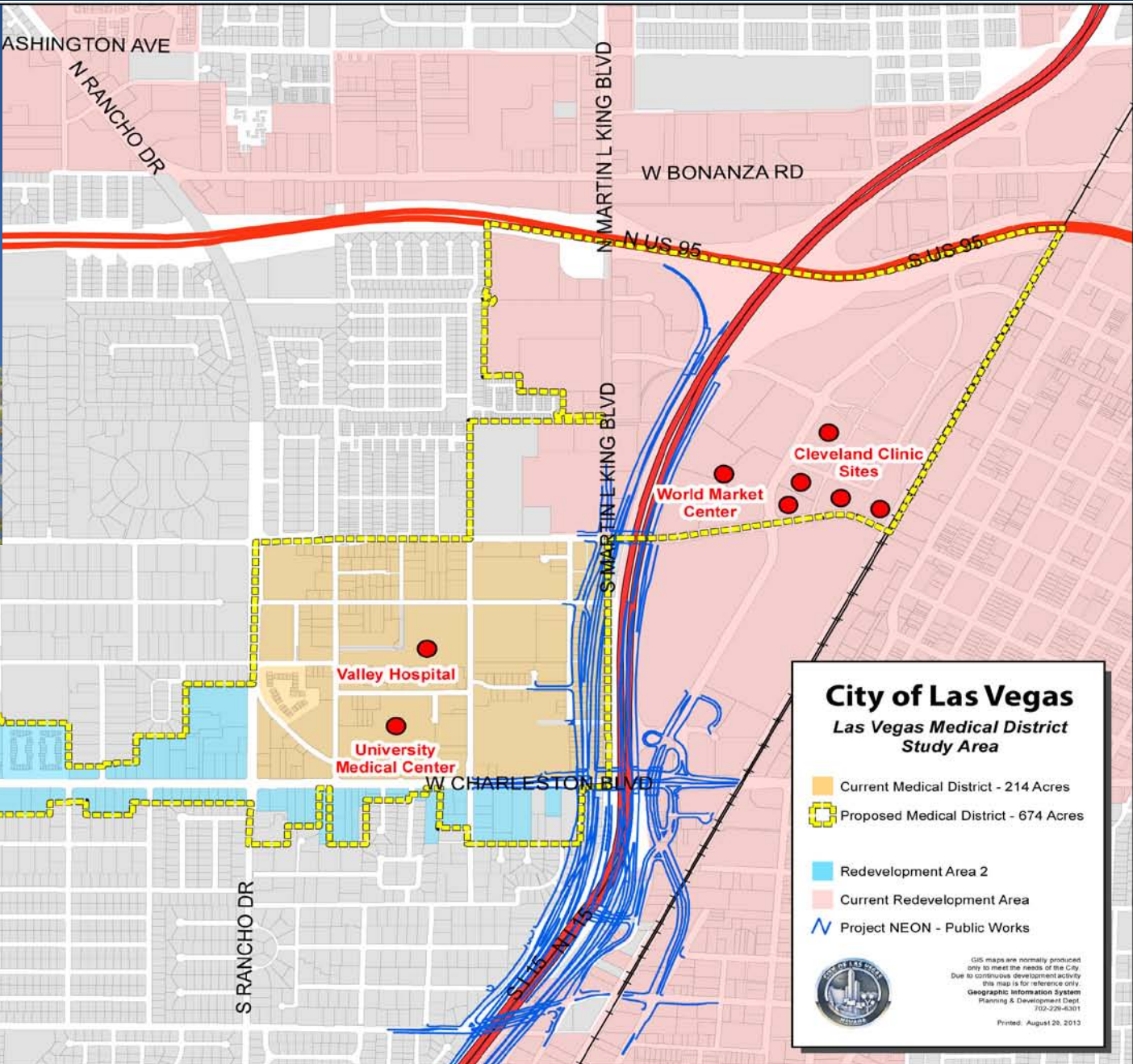
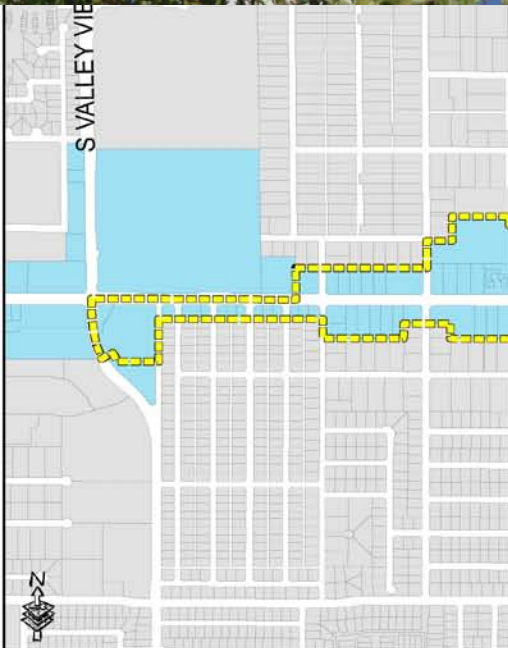

LV Medical District – Advisory Council

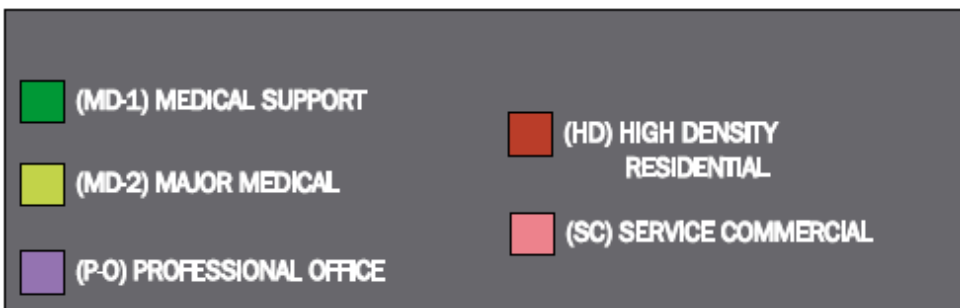
- Key stakeholders focused on the redevelopment and growth of an academic medical center of excellence.
- The Advisory Council consists of two subcommittees:
 - Planning: The focus is to develop a long-range master plan for the district
 - Marketing/PR: The mission is to develop a brand and public relations strategy that will increase awareness and drive development and business to the area.



LV Medical District – City Master Plan Revisions



- City Planning is currently updating the district master plan to reflect the current and future needs of this academic medical center.
- The revised plan should be completed and ready for council approval in early Fall 2014.





LV Medical District – Southern NV Strong

- This collaborative regional planning effort that has identified the medical district as a focus area.
- The goals include:
 - Ensuring that a range of supportive uses can be accommodated in and around the district
 - Appropriate and diverse transportation access
 - Recognize any public facilities deficiencies and create plans to address them
 - Ensuring safety concerns and district walkability are addressed
 - Identify development opportunities



LV Medical District – SC2 Grant

- The Strong Cities, Strong Communities Challenge is a federally developed incentive-based competition, funded through a \$1M EDA Grant
- The Las Vegas Medical District is one of four areas of focus
- Multidisciplinary teams have an opportunity to win a total of \$800,000 in prizes throughout two phases of the competition
- The challenge began February 4, 2014; participant registration deadline is in July 2014
- Phase 1 winners will be announced in November 2014, and the grand prize winner will be selected in June 2015

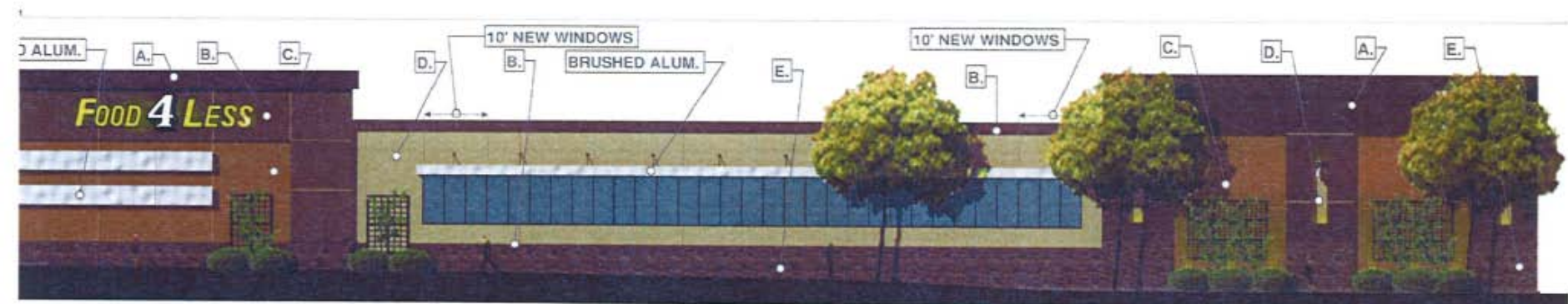

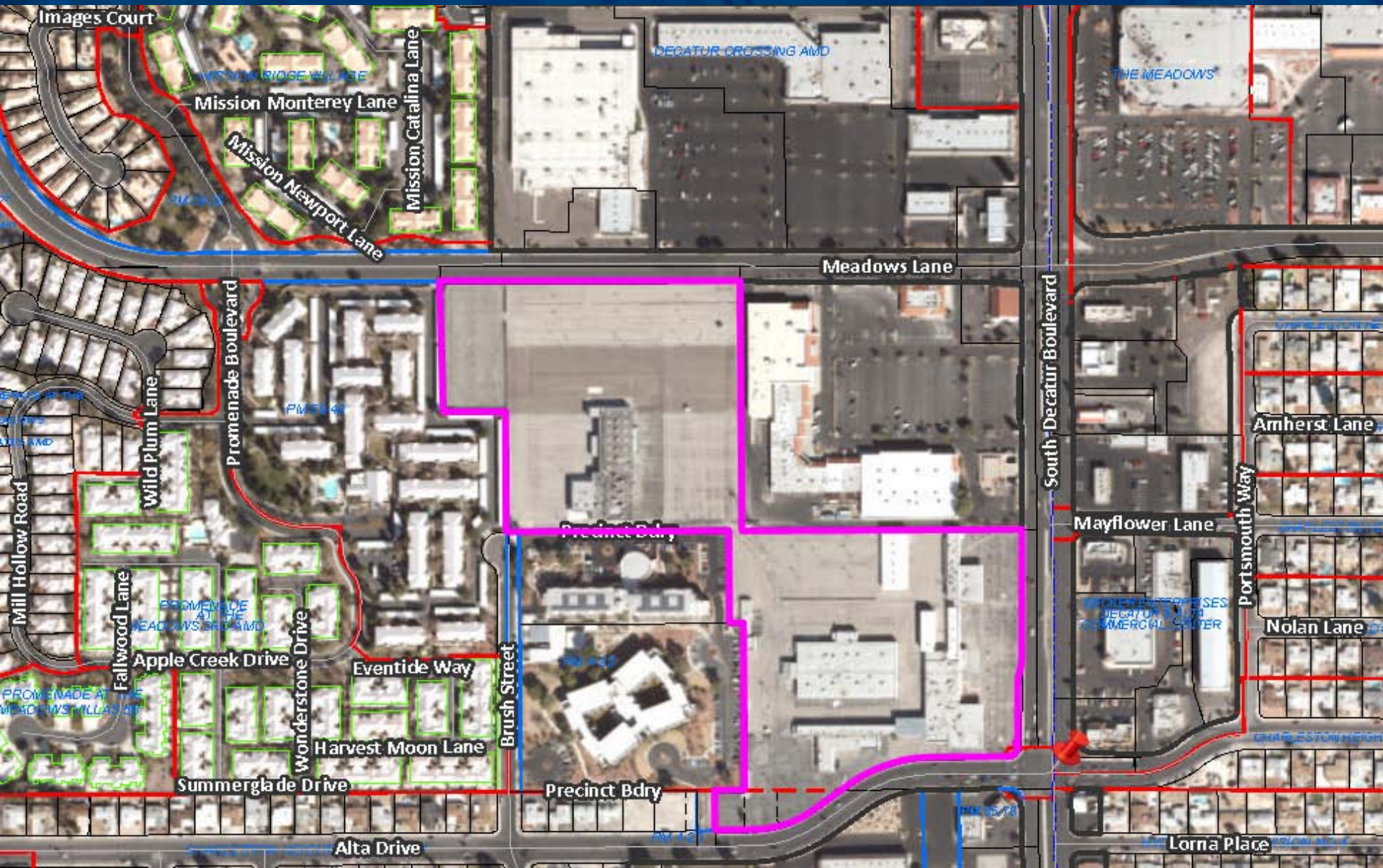
