AN ORDINANCE TO ADOPT AN UPDATED SYMPHONY PARK DESIGN STANDARDS MANUAL,
AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Adopts an updated Symphony Park
Design Standards Manual.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS
FOLLOWS:

SECTION 1: The Symphony Park Design Standards Manual, along with the Appendices
thereto, was duly adopted by Ordinance No. 6102, and presently is incorporated by reference into Section
19.10.110 of the Unified Development Code, which section is the successor to a similar section that
originally was codified as LVMC 19.06.060. The document of the same name that is attached hereto is
hereby adopted, is incorporated by reference into Section 19.10.110 of the Unified Development Code, and
shall replace and supersede the previous version of the Symphony Park Design Standards Manual.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or
phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City
of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph,
sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections,
subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.
