3 AN ORDINANCE TO AMEND ORDINANCE NO. 6294 (REGARDING THE EXTENSION OF THE
4 CORPORATE LIMITS OF THE CITY) TO CORRECT LANGUAGE REGARDING THE EFFECTIVE
5 DATE OF THAT ORDINANCE, AND TO PROVIDE FOR OTHER RELATED MATTERS.
(PERTAINING TO ANNEXATION ANX-49991)

Summary: Amends Ordinance No. 6294, relating
to the annexation of property, to correct language
regarding the effective date of that ordinance
(General Location - the southwest corner of Farm
Road and Grand Canyon Drive).

9 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS
10 FOLLOWS:

11 SECTION 1: Ordinance No. 6285 of the City of Las Vegas was adopted on October 2,
12 2013, with an effective date of October 11, 2013, to accomplish the annexation into the City of certain
13 territory. A copy of that ordinance is attached. Ordinance No. 6294 of the City of Las Vegas was adopted
14 on January 22, 2014, to correct the City's equivalent zoning designation of the territory described in
15 Ordinance No. 6285. Section 3 of Ordinance No. 6294 contained inaccurate language regarding its
16 intended effective date. Therefore, the City Council desires to amend Section 3 of Ordinance No. 6294 to
17 read as follows:

18 **SECTION 3: The amendment represented in Section [1] 2 of this**
19 **Ordinance shall be effective as of the effective date of Ordinance No. 6285.**

20 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or
21 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
22 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
23 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City
24 of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph,
25 sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections,
26 subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

1 SECTION 3: All ordinances or parts of ordinances or sections, subsections, phrases,
2 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983
3 Edition, in conflict herewith are hereby repealed.
