Sign Criteria

The purposes of the Master Sign Plan (hereinafter referred to as “Criteria”) are to establish sign standards necessary to have adequate Tenant identification within an overall harmony of design for assessors parcel # 138-29-801-002, commonly known as Angel Park Golf Club.

1. Tenant’s obligations:

At its sole cost and expense, Tenant shall be responsible for:

- a. Obtaining all necessary approvals and the fulfillment of all governmental requirements, including but not limited to compliance with all applicable building and electrical codes;
- b. Criteria conformance and specifications herein stated;
And
- c. Sign design, construction, installation, and maintenance of Tenant’s signage.

2. Sign Design:

Detailed drawings shall consist of sign placement, exact size, layout, copy, design and color, lighting and materials of proposed signs, including all lettering and or/graphics, dimensional working, drawings, as well as a drawing showing the proposed finished sign(s) in color.

3. Sign Approval:

All signs shall be reviewed by City of Las Vegas Planning Department and Sign contractor for conformance with Criteria, overall design quality, and compatibility with regard to the character intended for Angel Park Golf Club. Any deviation from the Criteria will require filing for an amendment to the master sign plan.

4. Fabrication and Specification of Sign(s):

All Signs shall be made of permanent materials. All metal parts shall be galvanized or permanently coated with a rust inhibiting finish. All signs structures, supports, fittings and hardware shall be concealed or integrated into the signage design.

5. Sign standards:

Standards for signage within Angel Park shall be the same as those indicated in LVMC 19.08.120 for the P-O District with the following additional standards:

- a. Non-illuminated letters identifying the name of Angel Park may be permanently set on the wall of the building providing the sign does not exceed fifty square feet.
- b. Signs on buildings meeting the foregoing criteria may be permitted on structures which are a part of the institutional architecture or which are symbolic of the institution and the permitted square footage and maximum height of building signs shall apply only to the written message.
- c. In addition to the indicated signs, additional signs may be permitted and subject to review and approval of the Planning Commission as to each case.

6. Freestanding Signs:

Angel Park to have (1) double face freestanding sign located on the western point of 25 S. Durango. Sign to be located per City of Las Vegas requirements for setbacks, landscaping, and design as follows:

- a. Pole sign to be double face with an overall height of 30'-0" and 187 square foot.
- b. Pole sign to have a (1) double face full color LED message unit. Advertisements shall be limited to that of Angel Park Golf Club itself and upcoming events related to the golf course and shall not include the advertisement of associated products sold on site.
- c. Copy to be LED illuminated reverse channel letters reading "ANGEL PARK-Golf Club". Secondary copy to be internally LED illuminated push through plex reading "Nino's Kitchen".
- d. Sign to be texcoated and painted to match existing buildings located at 100 S. Rampart Blvd.
