**PURPOSE/BACKGROUND:**

On April 1, 2014 the Board of Directors of the Las Vegas Valley Water District approved the award of Bid No. 2249-13 for an annual requirements contract for Bio-Diesel and #2 Diesel Fuel to Rebel Oil Company, Inc. This agreement will provide for the purchase and delivery of these fuels for use by the City of Las Vegas. This item is exempt from the competitive bidding process pursuant to NRS 332.195, which allows local government to use the contracts of other local governments with the authorization of the contracting supplier. Rebel Oil Company, Inc. is located in Las Vegas, Nevada.
