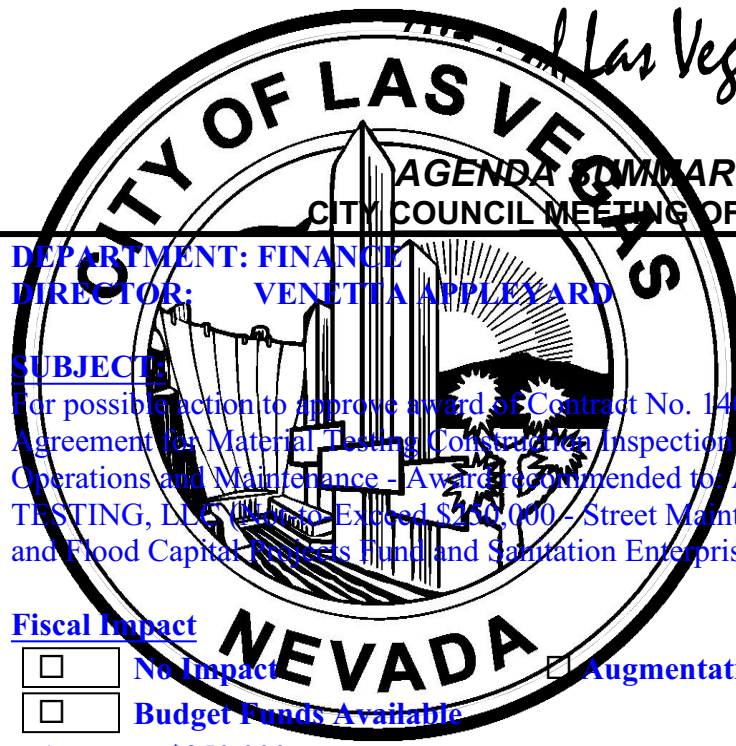

PURPOSE/BACKGROUND:

This contract provides for engineering services, material testing and construction inspections for various projects as requested on a task order basis by the Department of Operations and Maintenance. Award of this contract is recommended by the City of Las Vegas consultant selection committee based upon the 2012 Statement of Qualifications process.
