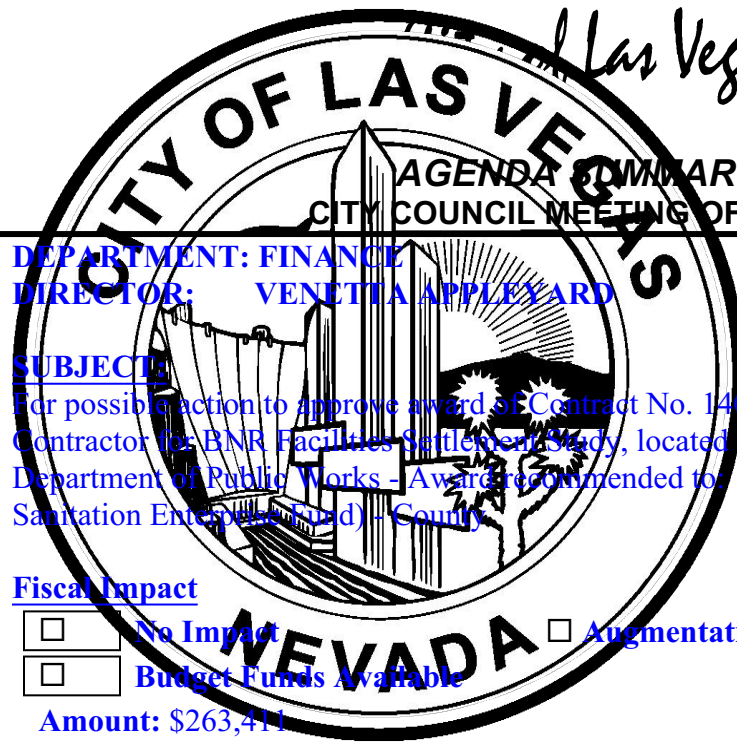

PURPOSE/BACKGROUND:

This project consists of an investigation into the severity of settling of the BNR Facilities at the WPCF to develop recommendations for future rehabilitation or stabilization of the facility. Scope will include a geotechnical review of existing soils reports and as-built documents and additional subsurface investigations; structure review of the as-built documents; facility inspection for damage; and a mechanical review of the building piping and mechanical equipment. Scope also includes identification of monitoring points to establish a base line survey and identify and measure future settlement. Award of this contract is recommended by the City of Las Vegas consultant selection committee based upon the 2012 Statement of Qualifications process. This item is exempt from the competitive bidding process pursuant to NRS 332.115(b), Professional Services. Brown and Caldwell have an office located in Las Vegas.
