

**Application for \$4,000 Grant for Park Benches & Stepping Stones
Quail Ridge Drive HOA - June 2014**

MY NAME IS BARBARA JUDY. I AM PRESIDENT OF THE QUAIL RIDGE DRIVE SUB-ASSOCIATION IN SUN CITY SUMMERLIN.

WE BOARD MEMBERS COME BEFORE YOU TODAY REQUESTING \$4,000 IN GRANT MONEY TO ENHANCE THE COMMON AREAS OF OUR COMMUNITY. OUR HOA CONSISTS OF 66 HOMES, WHICH ARE THREE ROWS OF HOMES ON TWO STREETS. WE ARE RESPONSIBLE FOR IMPROVEMENTS THAT ARE MADE WITHIN OUR COMMUNITY. THE OVERALL ASSOCIATION, *DEL WEBB SUN CITY SUMMERLIN*, DOES NOT REGULATE OUR IMPROVEMENTS SO LONG AS IT IS NOT AN ACTUAL STRUCTURE. YOU HAVE RECEIVED A COPY OF THE LETTER STATING THIS FROM THE SUN CITY PRESIDENT.

SINCE 2008, WE HAVE BEEN ENJOYING OUR *BACKYARD PARTIES* IN THE GREENWAY. ALL THE RESIDENTS BRING CHAIRS, TABLES, FOOD, AND SOCIALIZE. THESE BEGAN AS AN EXPERIMENT, AND IN SPITE OF SOME "NAY-SAYING", THE GATHERINGS BECAME SO POPULAR THAT PEOPLE ASKED TO HAVE THEM TWICE A YEAR. WE WERE PRIVILEGED TO HAVE OUR WARD 4 COUNCILMAN STAVROS ANTHONY ATTEND AND HELP "*KICK-OFF*" OUR FIRST PARTY.

IT HAS BEEN OUR WISH FOR SEVERAL YEARS TO ADD BENCHES TO THE GREEN SPACE BETWEEN TWO ROWS OF HOUSES. AT PRESENT, THERE IS ONLY GRASS, TREES AND A STRIP OF GRAVEL 18ft WIDE DOWN THE MIDDLE. THIS IS WHERE THE BENCHES WOULD BE LOCATED.

TWO BENCHES FACING ONE ANOTHER IS THE EPITOMY OF NEIGHBORHOOD PARTNERS.

FOUR PEOPLE SITTING ON THOSE BENCHES IS THE EPITOMY OF CAMARADERIE AND THE BEGINNING OF NEW FRIENDSHIPS.

BENCHES HAVE BEEN SHOWN TO INCREASE “*ACTS OF NEIGHBORING*” IN CITY PLANNING, ACCORDING TO Sjaekveland (2001).

IN ADDITION TO OUR PARTIES, WE BELIEVE RESIDENTS WOULD LIKE TO WALK OUT THEIR BACK DOOR, HAVE A CONVENIENT BENCH TO REST AND RELAX, ENJOY THE FRESH AIR, AND VISIT WITH THEIR NEIGHBORS. OUR PLAN IS TO PLACE TWO BENCHES FACING ONE ANOTHER AT FOUR LOCATIONS THROUGHOUT THE AREA BEHIND THE HOUSES, MAKING IT CONVENIENT FOR EVERYONE.

ALSO, STEPPING STONES WOULD ENHANCE WALKING ACROSS GRAVEL AREAS BETWEEN HOUSES, AS THEY COME TO THE PARTIES OR TO SIT AND VISIT WITH THE NEIGHBORS. A WIDE PATH OF STEPPING STONES LOCATED BETWEEN THE HOUSES WOULD ALLOW THOSE IN WHEELCHAIRS, OR USING WALKERS OR CANES, TO NAVIGATE MORE EASILY.

IN ESSENCE, THE GRANT MONEY WOULD BE USED TO PURCHASE BENCHES, STEPPING STONES, AND TO HIRE A HANDYMAN TO ASSEMBLE AND ANCHOR THE BENCHES. WE ALSO HAVE OFFERS FROM MANY OF OUR RESIDENTS TO ASSIST WITH THIS PROJECT.

THESE ITEMS WOULD INCREASE THE NEIGHBORHOOD INTERACTION, SAFETY, AND ACTIVE PARTICIPATION AND LIFESTYLE OF OUR HOA RESIDENTS.

3. HISTORY: FIRST FULL HOA BOARD BEGAN IN 2002

BY 2006 MAJOR ISSUES WITH SERIOUS HOME CONSTRUCTION DEFECTS (HVAC/ELECTRICAL/PLUMBING), HOA DUES UNDER FUNDED, MULTIPLE BOARD RECALLS, LAWSUIT, HOMEOWNER MEETING DISTURBANCES

2009: FIRST COHESIVE COMMUNITY ACTION – REPLACED ALL NATURAL GAS LIGHTING WITH LOW VOLTAGE ELECTRIC.

2014: SECOND COHESIVE COMMUNITY ACTION – CENTURY LINK ACCESS & UPGRADES
