**PURPOSE/BACKGROUND:**

This item provides for engineering services to complete missing sidewalk segments on three roadways. Award of this contract is recommended by the City of Las Vegas consultant selection committee based upon the 2012 Statement of Qualifications process. This item is exempt from the competitive bidding process pursuant to NRS 332.115.1(b), Professional Services.
