PURPOSE/BACKGROUND:

This project consists of sawcutting and removal of existing asphalt pavement, removal of existing sanitary sewer and appurtenances, installation of sanitary sewer and appurtenances, Cured-in Place Pipe (CIPP) and CIPP liner, mechanical point repair, applying corrosion protective coating to existing sanitary sewer manholes, replacing components of existing manholes, raising manholes to grade, by-pass sewer diversion, odor control, replacement of asphalt pavement, striping, and traffic control. Las Vegas Paving Corporation is located in Las Vegas, Nevada.
