The city's Department of Parks and Recreation is proposing to increase a number of fees for facilities and services the Department provides. This notice is intended to provide an opportunity for input from businesses (for-profit enterprises) regarding the potential business impact of several proposed fee increases, namely, increase in fees relating to sports field lighting, park pavilion rentals, Floyd Lamb Park annual passes, special events park rentals and community center rentals. The proposed increases are as follows:

I. SPORTS FIELD LIGHTING
